- From 13-14 September, 2017, His Excellency Shinzo Abe, Prime Minister of Japan was on an official visit to India on September along with his wife Aki Abe.
- He was formally welcomed at Sardar Vallabh Bhai Patel International Airport, Ahmedabad.
- After this, he paid tribute to Mahatma Gandhi in Sabarmati Ashram in Ahmedabad.
- During this visit, he visited the ancient Syedi Syed Mosque in Ahmedabad with Prime Minister Narendra Modi.
- On September 14<sup>th</sup>, 2017 Prime Minister Narendra Modi and Shinzo Abe jointly laid the foundation stone of India's first high-speed rail project between Ahmedabad and Mumbai.
- For this project, Japan has given a loan of 88 thousand crores to India for 50 years at an interest rate of 0.1 percent.
- After this he visited the museum at Dandi cottage in Gandhinagar dedicated to Mahatma Gandhi.
- After this, 12<sup>th</sup> India-Japan Annual Summit was organised at Mahatma Mandir in Gandhinagar, Gujarat on the 14<sup>th</sup> of September.
- 15 MoUs / agreements between the two countries were signed after delegation level talks.
- Major agreements are as follows:
- Aims to cooperate and collaborate in the field of disaster risk reduction and to share the experiences, knowledge and policies on disaster prevention.
- To further strengthen bilateral relations and cooperation in the field of Japanese language education in India.
- To enhance connectivity and promote developmental projects in the North Eastern Region of India in an efficient and effective manner.

- Aims at implementing the commercial arrangement of "Cool EMS" service between the Japan Post and India Post through which fresh food can be sent from Japan to India in cool boxes to facilitate for the Japanese expatriates in India.
- To facilitate and accelerate the Japanese investments in India.
- To cooperate in infrastructure development programmes in the Mandal Bechraj-Khorajregion.
- It opens skies between India and Japan i.e. Indian and Japanese carriers can mount now unlimited number of flights to the selected cities of each other's countries.
- To conduct joint research and to establish an International Centre named as "<u>D</u>BT-AIST <u>International CENter for Translational & Environmental Research</u> (DAICENTER)" at AIST, Japan in order to promote science and technology in both the institutions and countries.
- To promote research collaboration between DBT Research Institutes and AIST in the field of Life Science and Biotechnology.
- To facilitate and deepen international education cooperation and exchanges betweenLakshmibai National Institute of Physical Education, India and Nippon Sport Science University, Japan.
- To facilitate and deepen international education cooperation and exchanges between both Sports Authority of India and Nippon Sport Science University, Japan.
- To strengthen strategic collaboration, joint research programmes and exchanges betweenLakshmibai National Institute of Physical Education, India and University of Tsukuba, Japan.
- To strengthen strategic collaboration, joint research programme and exchanges betweenUniversity of Tsukuba, Japan and Sports Authority of India.
- To promote institutional cooperation between RIS and IDE-JETRO to strengthen the capacity of research and effectiveness of dissemination of research findings.

- On September 25<sup>th</sup>, 2017, on the occasion of the birth anniversary of Pandit Deendayal Upadhyay, Prime Minister Narendra Modi launched the Pradhan Mantri Sahaj Bijli Har Ghar Yojana, 'Saubhagya' in New Delhi.
- The objective of this scheme is to provide electricity to every household in all rural and urban areas of the country.
- Under this scheme, the States and Union Territories are required to complete the works of household electrification by the 31<sup>st</sup> of December 2018.
- The total outlay of the project is Rs. 16, 320 crorewhile the Gross Budgetary Support (GBS) is Rs. 12,320 crore.
- The outlay for the rural households is Rs. 14,025 crore while the GBS is Rs. 10,587.50 crore.
- For the urban households the outlay is Rs. 2,295 crore while GBS is Rs. 1,732.50 crore.
- The Government of India will provide largely funds for the Scheme to all States/UTs.
- Under the scheme, the beneficiaries for free electricity connections would be identified using Socio Economic and Caste Census (SECC) 2011 data.
- However, un-electrified households not covered under the SECC data would also be provided electricity connections under the scheme on payment of Rs. 500 which shall be recovered by DISCOMs in 10 instalments through electricity bill.
- The solar power packs of 200 to 300 Wp with battery bank for un-electrified households located in remote and inaccessible areas, comprises of Five LED lights, One DC fan, One DC power plug. It also includes the Repair and Maintenance (R&M) for 5 years.
- For easy & accelerated implementation of the Scheme, modern technology shall be used for household survey by using Mobile App.
- The Rural Electrification Corporation Limited (REC) will remain the nodal agency for the operationalisation of the scheme throughout the country.

- Parameters for a clean campus were formulated, like student/toilet ratio, kitchen hygiene, availability of running water, modernity of toilet & kitchen equipment, campus green cover, garbage disposal, disposal techniques and water supply systems in hostels and academic buildings.
- Apart from this, institutions those have adopted any neighboring locality or village to spread awareness & activities in Swachhta a certain weightage was given to them.
- About 3500 higher educational institutions responded to the online invitation, submitting all their details as per format.

- This policy is prepared by the Department of Micro and Small Enterprises after consultation with the stakeholders including the vehicle manufacturing industries.
- The aim of this policy is to promote research and development to increase in this sector and electric mobility.
- The government will make amendments to building by-laws for providing mandatory charging infrastructure in all high-rise buildings.
- The government will also create a special purpose vehicle to create more changing infrastructure in Bengaluru and Karnataka.
- A Karnataka Electric Mobility Research and Innovation Centrewill also be setup to promote the research in the state.
- In is note worthy that Government of India is promoting the use of Electric Vehicles (EVs) in India and has ambitious to convert all vehicles into electric powered by 2030.

Related Facts:



- On September 2<sup>nd</sup>, 2017 in the meeting of the State Cabinet, it was decided to set up a new corporation for buying, medical-equipment and other health related services in the state.
- The name of this new corporation will be 'Uttar Pradesh Medical Supplies Corporation'.
- It will be formed under the Companies Act, 2013.
- Its main purpose is to purchase medicines, equipments, consultants and non-services for medical, health and family welfare and other departments in the state and to purchase contracts under public-private partnership and purchase of other health related services.
- Drug storage centers and logistics will be established under the Corporation to ensure the storage and distribution of medicines.
- Transparent earnings and distribution system will be implemented through information technology.
- Its headquarters will be set up in Lucknow.
- The Corporation will be funded by 100 percent Uttar Pradesh government and will be started with a share capital of Rs. 20 crore.
- This equity will be divided into 2,00,00,000 (two crore) shares of Rs 10 each.
- Under the Companies Act, 2013, 11 promoters / directors of the company will hold one share of Rs 10 each and the remaining shares will be in the name of the governor through the state government.
- The above mentioned 11 shareholder corporations will also be the first Board of Directors, who will be nominated by the government on the basis of designation.
- The Central Drug Store established in the Directorate of Medical and Health will be abolished with the establishment of this corporation.

 On September 19th, 2017, the Union Minister of State (Independent Charge) Development of North-Eastern Region (DoNER), MoS PMO, Personnel, Public Grievances

& Pensions, Atomic Energy and Space, Dr Jitendra Singh inaugurated the first 'Pension Adalat.

- He also honored the Pensioners for their outstanding contribution towards 'Anubhav'.
- 'Anubhav' is a platform for retiring employees for sharing their experience of working with Government.
- Moving ahead from e-governance to m-governance, a Mobile App, created to avail the services of Pensioners' Portal was also launched by him.
- With this App, a superannuating Central Government official will be able to monitor the progress of his pension settlement, and retired officials will be able to self-assess their pension through the pension calculator and will also be able to register their grievances, if any, and get updates on orders issued by the Department.

- As a measure of welfare to the pensioners of Government of India, a workshop on Pre-Retirement Counseling (PRC) of 300 retiring Central Government employees was also held.

- nitially National Oil Companies (NOCs) are meeting the fund requirement from their own sources, which will be reimbursed by the Government.

- According to the report, the year 2006 seeing 4, 80,652 road accidents as against 5, 01,423 in 2015.
- Nearly 1, 50,785 persons were killed in 2016 as against 1, 46,133 in 2015.
- Road accidents in the country have decreased by around 4.1% however fatalities resulting from these accidents have risen by about 3.2% for the same period.
- There has been a 3 % reduction in road accidents between January to July 2017, along with a 4.75 % reduction in road accident fatalities.
- During 2016, 13 States accounted for 86 per cent of the total road accidents in the country.
- These are Tamil Nadu, MP, Karnataka, Maharashtra, Kerala, UP, AP, Rajasthan, Telangana, Gujarat, Chhattisgarh, West Bengal and Haryana.
- Similarly, 13 States accounted for 84 per cent of the total persons killed in road accidents during 2016.
- These are UP, Tamil Nadu, Maharashtra, Karnataka, Rajasthan, MP, AP, Gujarat, Telangana, West Bengal, Punjab, Haryana and Bihar.
- Chennai had the highest number of road accidents (7,486).
- Delhi had the highest number of deaths (1,591)) due to road accidents.
- According to the publication, the age profile of road accident victims for 2016 reveals that the percentage accounted by different Youth age group is as follows-

Age group	Percentage
-----------	------------

18 – 35 years	46.3 per cent (69,851 persons)
18-45 years	68.6% (1,03,409 persons)
18-60 years	83.3 per cent (1,25,583 persons)

- Number of accidents per lakh population declined from 42.5 in 2010 to 37.9 in 2016.
- Number of persons injured per lakh population decreased from 44.8 in 2010 to 39.0 in 2016.
- Number of persons killed per lakh population marginally increased from 11.4 in 2010 to 11.9 in 2016.
- The National Highways accounted for 29.6 per cent of total road accidents and 34.5 per cent of total number of persons killed.
- The share of two wheelers in total road accidents has increased from 28.8 per cent in 2015 to 33.8 per cent in 2016.
- The other road users killed in road accidents are cars, taxies, vans and other light and medium motor vehicles – 17.9 per cent; trucks – 11.2 per cent; pedestrians – 10.5 per cent; buses – 6.6 per cent; auto rickshaws – 4.7 per cent; and others motor vehicles – 10.6 per cent.
- The share of two wheelers in total road accidents has increased from 28.8 per cent in 2015 to 33.8 per cent in 2016.

- 'Maharatna' Central Public Sector Undertaking can invest Rs. 5000 crores in a project.
- The CPSEs fulfilling the following criteria are eligible to be considered for grant of Maharatna status:
- Having Navratna status.
- Listed on Indian stock exchange with minimum prescribed public shareholding under SEBI regulations.
- Average annual turnover of more than Rs. 25,000 crore, during the last 3 years.
- Average annual net worth of more than Rs. 15,000 crore, during the last 3 years.
- Average annual net profit after tax of more than Rs. 5,000 crore, during the last 3 years.
- Should have significant global presence/international operations.
- In order to help the central government identify the central public sector undertakings with a comparatively beneficial situation and help them emerge as huge enterprises at the international level, the central government started the 'Navaratna' scheme in 1997.
- Criteria for grant of Navratna status:
- The Miniratna Category I and Schedule 'A' CPSEs, which have obtained 'excellent' or 'very good' rating under the Memorandum of Understanding system in three of the last five years, and have composite score of 60 or above in the six selected performance parameters, namely,
- Net profit to net worth,
- Manpower cost to total cost of production/services,
- Profit before depreciation, interest and taxes to capital employed,
- Profit before interest and taxes to turnover,
- Earning per share and
- Inter-sectoral performance.
- At present, the Central Government has given 17 CPSEs as 'Navaratnas' status, which are as follows:

- (12) Hindustan Petroleum Corporation Ltd.

- The Global Human Capital Index 2017 ranks 130 countries on how well they are developing their human capital on a scale from 0 (worst) to 100 (best).
- The measurement is based on four thematic dimensions and five distinct age groups to capture the full human capital potential profile of a country.
- Four thematic dimensions are:

I. Capacity, largely determined by past investment in formal education;

II. Deployment, the application and accumulation of skills through work;

III. Development, the formal education of the next generation workforce and continued upskilling and reskilling of existing workers; and

IV. Know-how, the breadth and depth of specialized skills-use at work.

- Five distinct age groups or generations: 0-14 years; 15-24 years; 25-54 years; 55-64 years; and 65 years and over.
- Under this to measure the human capital rank of any country, the level of knowledge and skill of the people of that country to make a significant contribution in the global financial system is kept in mind.
- In the Global Human Capital Report-2017, Norway (Score 77.12) is at the top.
- Norway is followed by Finland (Score: 77.07), Switzerland (Score: 76.48), America (Score: 74.84) Denmark (Score: 74.40) respectively.
- Yemen (Score-35.48) is ranked in the bottom at the 130th position in this report.

- This bank has been started with the objective of keeping the smooth supply of the enriched uranium.
- According to the International Atomic Energy Agency, this storage is for those conditions where any member of the United Nations cannot achieve nuclear fuel for any reason.
- For this project financial aid was provided by the United States America, more than two dozen countries of the European Union, Kuwait, United Arab Emirates and Norway.
- The International Atomic Energy Agency was created on July 29, 1957, with its headquarters located in Vienna, Austria.

- On September 15, 2017, the 23rd issue of the Annual Publication 'India's External Debt: A Status Report 2016-17' prepared by the Department of Economic Affairs, Ministry of Finance, Government of India was released.
- Repots presents a detailed analysis of India's External Debt position at end-March 2017, based on the data released by the Reserve Bank of India (RBI) on June 30, 2017 and data and information available from other sources.
- The salient features of the Report are:
- India's external debt stock stood at US\$ 471.9 billion at end-March 2017, decreasing by US\$ 13.1 billion (2.7 per cent) over the level at end-March 2016.
- The decline in external debt was due to the decrease in long-term debt particularly NRI deposits and commercial borrowings.
- At end-March 2017, long-term external debt was US\$ 383.9 billion, showing adecrease of 4.4 per cent over the level at end-March 2016.
- Long-term external debt accounted for 81.4 per cent of total external debt at end-March 2017as compared to82.8 per cent at end-March 2016.
- Short-term external debt increased by 5.5 per cent to US\$ 88.0 billion at end-March 2017. This is mainly due to the increase in trade related credits, a major component of short-term debt with a share of 98.3 per cent.
- Government (sovereign) external debt increased from US\$ 93.4 billion at end-March 2016 to US\$ 95.8 billion at end-March 2017, and constituted 20.3 per cent of the total external debt, as compared to 19.3 per cent in the previous year.
- India's external debt has remained within manageable limits and the external debt situation has improved n 2016-17 over 2015-16 as indicated by the increase in foreign exchange reserves cover to debt to 78.4 per cent from 74.3 per cent, and fall in the external debt-GDP ratio to 20.2 per cent from 23.5 per cent.
- External debt of the country continues to be dominated by the long-term borrowings.
- It is worth noting that the World Bank's 'International Debt Statistics 2017', which has presented loan data for 2015, shows that India is still counted in 'less unsafe' countries.
- India's foreign credit indicators are better than other indebted or indebted developing countries.
- The ratio of external debt and gross national income to India is 23.4 percent, which reflects the fifth lowest level.
- Similarly in terms of cover provided by foreign exchange reserves for foreign debt, India was at the sixth highest level with 69.7 percent in year 2015.

Implementation has released the estimates of Gross Domestic Product(GDP) for the first quarter (April-June) Q1, of 2017-18, both at constant (2011-12) and current prices.

- The estimates have been released along with the corresponding quarterly estimates of expenditure components of the GDP.
- GDP at constant (2011-12) prices in Q1 of 2017-18 is estimated at 31.10 lakh crore, as against 29.42 lakh crore in Q1 of 2016-17.
- It is showing a growth rate of 5.7 percent.



- The economic activities which registered growth of over 7 percent in Q1 of 2017-18 over Q1 of 2016-17 are 'trade, hotels, transport & communication and services related to broadcasting', 'public administration, defence and other services' and 'electricity, gas, water supply & other utility services'.
- The growth in the 'agriculture, forestry and fishing', 'mining and quarrying', 'manufacturing', 'construction' and financial, insurance, real estate and professional services is estimated to be 2.3 per cent, (-) 0.7 percent, 1.2 per cent, 2.0 percent and 6.4 percent respectively during this period.
- GDP is derived by adding taxes on products net of subsidies on products to GVA at basic prices.
- GDP at current prices in Q1 of 2017-18 is estimated at 38.84 lakh crore, as against 35.55 lakh crore in Q1 of 2016-17, showing a growth rate of 9.3 percent.
- GVA at Basic Price at current prices in Q1 of 2017-18, is estimated at 35.77 lakh crore, as against 33.17 lakh crore in Q1, 2016-17, showing an increase of 7.9 percent.
- Growth in collection of Union excise duties, customs duties and service tax was 7.3 percent, 15.0 percent and 20.4 percent respectively in Q1 of 2017-18 as against 60.5 percent, 17.8 percent and 28.5 percent respectively in Q1 of 2016-17.

- These Scorpene submarines are being built under Project 75.

- The state-of-art features of the Scorpene include superior stealth and the ability to launch a crippling attack on the enemy using precision guided weapons.
- The attack can be launched with torpedoes, as well as tube launched anti-ship missiles, whilst underwater or on surface.
- It can be operated in all seasons.
- This submarine is capable of carrying out various types of missions.
- These include anti-submarine warfare, anti-surface warfare information collection, field monitoring etc.
- 'Kalwari' is built from special steel, capable of withstanding high yield stress and having high tensile strength, thereby allowing them to withstand high hydrostatic force and enabling them to dive deeper to further enhance stealth.
- The ongoing project for the construction of six Scorpene class submarines has M/s DCNS of France, as Collaborator and includes 'Transfer of Technology', with M/s MDL as the 'Builder'.
- The cost of Scorpion submarines developed under Project-75 is approximately 3.5 billion dollars.
- The first Kalvari, which was also the first Indian submarine, was commissioned into the Indian Navy on 08 December 1967. She was decommissioned on 31 May 1996 after almost 30 years of yeoman service to the nation.

- This is the first time that India has defeated Sri Lanka by 5-0 on their soil.
- Indian bowler Jaspreet Bumrah, who took 15 wickets in the series, was selected as Player of the Series.
- Most 330 runs in the series are scored by Indian captain Virat Kohli.
- The first ODI in the series was the 200<sup>th</sup> match of Sri Lankan Lasith Malinga's ODI career.
- The second ODI in the series was Sri Lanka's 800<sup>th</sup> ODI match.
- In this match Sri Lankan spinner Akila Dhananjay joined the club (Hall) of 5 wickets takers in a match.
- Akila received 54 runs in 10 overs with 6 wickets.
- S Dhoni in the second match and Bhuvneshwar Kumar shared an unbeaten 100-run partnership for the 8th wicket.
- This is the highest partnership for the 8th wicket in ODIs against any country.
- In the third match, Chamara Kapugedara became Sri Lanka's 20th ODI captain.
- In this match, Jaspreet Bumrah joined the club (haul) of 5-wicket takers in a match.
- Bumrah taken 5 wickets giving 27 runs in 10 overs.
- Lasith Malinga became Sri Lanka's 21st ODI captain in the fourth one-dayer.
- In the fourth one-dayer match Virat Kohli shared a 219-run partnership with Rohit Sharma.
- With this, Virat has become the first cricketer to have done 200 or more runs (double century partnership) 10 times in one-dayers.
- The fourth match of the series, M.S. Dhoni was the 300<sup>th</sup> ODI, in which he made the world record of not being out.
- This was the 73rd occasion that in an ODI when Dhoni return at not-out (49 runs).
- Earlier this record was in the name of Sri Lanka's Chaminda Vaas and South Africa's. Shaun Pollack (72-72 times not out).
- In the fourth match, Sri Lanka lost by 168 runs, which is the biggest defeat on its own field in terms of runs.
- MS Dhoni in the fifth and final match of the series, stumped Akilia Dhananjay on the ball of Yajuwendra Chahal, became the world's first cricketer to do 100 stumpings in ODIs.
- He broke the record of 99 stumpings of former Sri Lankan cricketer Kumar Sangakara
- Dhoni has caught 283 catches behind the wicket in 301 ODIs.
- In the fifth match, Virat Kohli made his 30th century (in the 186th innings of 194th match) of his ODI career by playing an unbeaten innings.
- With this, Kohli has reached the second place with Australia's Ricky Ponting in terms of hitting the most hundreds in one-dayers.
- In the same series, he had secured third place in the list by breaking the record of 28 centuries in Sri Lanka's Sanath Jayasuriya.
- In ODIs record for hitting maximum 49 ODI centuries is in the name of Sachin Tendulkar (India).
- In the fifth match, Indian bowler Bhuvneshwar Kumar joined the club (Haul) of takers of 5 wickets in a match.

• In 9.4 overs Bhuvneshwar got 5 wickets giving 42 runs. **Reference:**



- The first supply of the locomotive engine of 12,000 horsepower by Alstom (France) reached the Calcutta port on September 20, 2017.



- This is the first high powered electric locomotive of its kind, which will be used to run at twice the speed of the current speed of the freight train from next year.
- In November 2015, Indian Railways had signed a contract with French company Alstom, to manufacture such engines for locomotive factories in Madhepura in Bihar.
- Under this agreement, 800 such engines will be built by the French company in the next 11 years.
- This is the first Foreign Direct Investment (FDI) project in the Rail Sector.
- The cost of this type of locomotive engine is estimated at Rs 30 crores.
- This locomotive engine will be tested in February -2018.
- Initially, five engines will be imported, while the remaining 795 engines are to be manufactured locally in support of the government's Make in India campaign.
- The total cost of this agreement is 3 billion Euros.
- This project will be set up in Madhepura of Bihar while two depots will be set up in Saharanpur (Uttar Pradesh) and Nagpur (Maharashtra) respectively for maintenance.
- This locomotive will be supplied from 2018 to 2028.
- The locomotive will run at a speed up to 120 km/h.
- At present, Railways is using 6000 Horse Power Engines for freight services.
- Under the scheme 35 locomotives will be ready by 2020, 60 locomotives in year 2021.
- After that, 100 locomotives will be made ready every year unless the target of 800 locomotives is completed.





- The bill will be subject to modifications of drafting or consequential nature, if any, as may be considered necessary by the Legislative Department by amending the Dentists Act, 1948 (16 of 1948).
- The amendment will reduce the redundancy.
- The clauses being amended include those pertaining to certain modifications in the provisions of the Dentists Act, 1948 with regard to:
- The membership of the Dental Council of India under clause (f) of section 3 and
- The membership of State and Joint State Dental Councils under clause (b) of section 21 and clause (b) of section 23 of the said Act.
- As per the existing Act, it was required to have the representation of dentists registered in Part B as Central Government nominees in the Dental Council of India and the election of four/ two members from Part B to the State/ Joint State Dental Councils.
