Related facts:



- President Ram Nath Kovind has signed the bill to declare abrogation of the provisions of Article 370 of the constitution, which gave special status to Jammu and Kashmir.
- Earlier, the government had moved the Jammu and Kashmir Reorganization Bill 2019 for consideration and passage in Lok Sabha on August 6, 2019.
- The bill, which will split J&k into two Union Territories, was passed by upper House (Rajya Sabha) though a voice vote and 125 were in favour while 61 were against.
- Along with this, the provisions of 10% reservation for Economically Weaker Sections (EWS) among the general category was also passed in the house.
- Important provision to the bill:
- Union Minister for Home affairs, Shri Amit Shah, introduced two bills and two resolutions regarding Jammu & Kashmir (J&K) Order, 2019{Ref. Article 370 (1) of Constitution of India} issued by President of India to supersede the 1954 order related to Article 370.
- Resolution for Repeal of Article 370 (3) which granted special status to the state of J&K. Under Article 370 (3), there is a provision that President on recommendation of the Parliament, has the power to amend or cease the implementation of Article 370, through a public notification.
- Jammu & Kashmir (Reorganization) Bill, 2019 {Ref. Article 3 of Constitution of India}.
  The Jammu and Kashmir (Reorganisation) Bill, 2019 strips Jammu and Kashmir's
  status of a state and splits it into two Union Territories-Jammu & Kashmir with a
  legislature and Ladakh without legislature.
- Jammu & Kashmir Reservation (2nd Amendment) Bill, 2019 having provisions of 10
  Percent reservation for economically Weaker Sections of upper caste in the state
  was also passed by the upper house. It will be applicable in educational institutions
  and public employment alongside existing reservation structure.

- With the removal of Article 370, Article 35 A will be also scrapped. Now, people from other states may also buy or purchase land and settle there.
- Article 35 A of the Indian Constitution was an article that empowered the Jammu and Kashmir state's legislature to define "Permanent residents" of the state and provide special rights and privileges to those permanent residents.

## 4th cycle of All India Tiger Estimation – 2018

Question: Which of the following state is at top in term of number of tigers in the released fourth cycle of All India Tiger Estimation – 2018 report?

Related facts:



- On 29 July 2019(Global Tiger Day), Prime Minister Narendra Modi released the fourth cycle of All India Tiger Estimation 2018, at Lok Kalyan Marg in New Delhi.
- As of the census, the count of tigers in India has risen to 2,967.
- The census figures 33% rise in tiger numbers which is highest ever recorded between cycles which stood at 21% between 2006 to 2010 and 30% between 2010 and 2014.
- Madhya Pradesh saw the highest number of tigers at 526, closely followed by Karnataka (524) and Uttarakhand (442).
- Chhatisgarh and Mizoram saw a decline in their tiger numbers while tiger's numbers in Odisha remained constant.
- On this occasion ,PM also released report of the 4th cycle of the Management Effectiveness Evaluation of Tiger Reserves (MEETR) with Pench Tiger Reserve, Madhya Pradesh scoring the highest and Sathyamangalam Tiger Reserve, Tamil Nadu showing the highest increment in management since the last cycle for which the latter was awarded.
- The evaluation of Tiger Reserves in India was initiated in 2006 and till now four cycles of evaluation have been completed.
- Project Tiger:
- To protect the national animal, the tiger, and reserve its landscape, Government of India had launched Project Tiger in 1973 during Prime Minister Indira Gandhi's tenure.

- Project Tiger is an ongoing Centrally Sponsored Scheme of the Ministry of Environment, Forests and Climate Change providing central assistance to the tiger States for tiger conservation in designated tiger reserves.
- From 9 tiger reserves since its formative years, the Project Tiger coverage has increased to 50 at present, spread out in 18 of our tiger range states.
- The National Tiger Conservation Authority (NTCA) is a statutory body of the Ministry, with an overarching supervisory / coordination role, performing functions as provided in the Wildlife (Protection) Act, 1972.
- In 2010, during the St. Petersburg declaration, tiger range countries had resolved to double tiger numbers by 2022.
- Due to concerted efforts under Project Tiger, at present India has the distinction of having the maximum number of tigers in the world.
- International Tiger Day:
- Global Tiger Day, often called International Tiger Day, is an annual celebration to raise awareness for tiger conservation, held annually on 29 July.
- It was created in 2010 at the Saint Petersburg Tiger Summit.
- The goal of the day is to promote a global system for protecting the natural habitats of tigers and to raise public awareness and support for tiger conservation issues.

- In a first of its kind, the famous Palani panchamirtham, given as 'prasadam' at Dhandayuthapani Swamy (Palani Murugan) temple in Tamil Nadu,has been granted the Geographical Indication (GI) tag.
- The panchamirtham is a combination of five natural substances — banana, jaggery, cow ghee, honey and cardamom. Dates and diamond sugar candies are added for flavour.



### The Panchamirtham:

- It is an 'abhishega prasadam' (food that is a religious offering), which is served in a semi-solid state.
- It is sweet in taste and one of the main offerings for Lord Dhandayuthapani Swamy, the presiding deity of Arulmigu Dhandayuthapani Swamy Temple, situated on Palani Hills.
- Not even a single drop of water is added during the preparation of the panchamirtham. This gives it its classic semi-solid consistency and taste.

## Tamil Nadu declare a State Butterfly

- It usually sized between 60 and 75mm, belongs to the family of brush-footed butterflies or the Nymphalid.
- Tamil Nadu became the fifth India state to declare its state butterfly after Maharashtra(Blue Mormon), Uttarakhand(Common peacock), Karnataka(Southern bird wings) and Kerala (Malabar banded peacock).

16 State Governments Sign MoU with Textiles Ministry to Impart Skill Training to Workers

 On August 14, 2019, Ministry of Textiles signed a Memorandum of Understanding with 16 State governments.



- The MoU signed to offer skill training programmes under the Samarth scheme.
- Also, 18 States agreed to partner with the Ministry under Samarth.
- The Ministry has allocated **Rs.35 lakh** for the implementation of the scheme.
- The States will nominate the agencies to implement the scheme.
- The agencies will train 4 lakh people who will be placed at the textile units.

### **Training Programme:**

- The training programme will cover the **entire value chain of the textiles sector.**
- The training programme involves advanced technology oriented features like Aadhaar Based Biometric Attendance System (AEBAS), CCTV recording, dedicated Call Centre, Mobile App based Management Information System and on-line monitoring.

### Samarth scheme:

- The 'Scheme for Capacity Building in Textile Sector (SCBTS)' known as (Samarth), aims to skill the youth for gainful and sustainable employment in the textile sector.
- It aims to promote **self-employment**, **entrepreneurial development** in traditional handloom, handicraft, jute, wool and silk segments.
- The Samarth scheme was implemented from 2010 to 2017. The scheme functions under the Ministry of Textiles.
- The Ministry of Textiles implemented the Integrated Skill Development Scheme with a target to provide **15 lakh additional skilled** workers to the textiles sector by 2017.
- The Ministry has extended the scheme now. By March 18, **11.14 lakh persons** were trained under the schema and **8.41 lakh persons** were provided placement.

 On 10 August, 2019; Vice President M Venkaiah Naidu launched the Jharkhand Government's Mukhya Mantri



Krishi Aashirwaad Yojana.

- The MMKAY scheme aims to ensure welfare and financial support to farmers in Jharkhand.
- The scheme has been incorporated in the state budget in financial year 2019-2020.
- This is the first scheme by the state government that provides 100 percent settlement through **Direct Benefit Transfer (DBT) medium**.
- Beneficiary farmers will get a minimum of Rs 5,000 and a maximum of Rs 25,000 per year under this scheme.
- This scheme for the Jharkhand farmers is apart from the Prime Minister's Pradhan Mantri Krishi Yojana.
- Initially under the first phase of the MMKAY scheme, Rs 5000 will be disbursed to 13.60 lakh farmers for each acre of their land with a maximum amount of Rs 25,000.
- The amount will be directly transferred through Real Time Gross Settlement (RTGS) to the registered bank accounts on August 10.
- The remaining 22 lakh farmers will also be registered soon and the funds are expected to be transferred by October this year.
- In this way over 35 lakh farmers will be benefited by getting the assistance ever year from the government under this scheme.

## World's first ultra-fast Hyperloop project granted to Maharashtra

Related facts:

- Maharashtra has granted infrastructure project status for a \$10-billion plan to build the world's first ultra-fast hyperloop project on 1st August, 2019.
- A hyperloop is an ultra-high-speed ground transportation system akin to bullet trains.
- The American transport tech firm 'Virgin Hyperloop One' will be constructing the route between Mumbai and Pune.
- 'Virgin Hyperloop One' firm is led by Richard Branson.
- This project stretching over 117.5km.
- The Mumbai-Pune hyperloop is expected to slash the 3.5 hour travel time between the two cities to 35 minutes.
- Hyperloops use magnets to levitate pods inside an airless tube, creating conditions in which the pods can shuttle people and freight at speeds of up to 1,200 km per hour.
- The first phase of the plan envisages an 11.8-km (7.33-mile) -long track to be built in up to 2-1/2 years with an investment of 50 billion Indian rupees (\$724 million) in Pune.

- Indian badminton star PV Sindhu with earnings of \$5.5 is the sole Indian included in the published list at 13th position.

## Global Assessment of forest Biodiversity by WWF

Question: Recently, World Wide Fund for Nature (WWF) published its report on Global assessment of forest Biodiversity; According to this report what was the percentage of forest wildlife populations on an average has declined since 1970?

Answer: (c) Related facts

- On 13 August, 2019; World Wide Fund for Nature (WWF) published its report on Global assessment of forest Biodiversity.
- Zoological Society of London (ZSL) & The UN Environment World Conservation Monitoring Centre (UNEP-WCMC) co-led the analysis and modeling for this report.
- The report, which has been published under the title Below the Canopy: Plotting Global Trends in Forest Wildlife Populations, is the first ever global assessment of forest diversity.
- According to this report the number of forest wildlife populations has declined on average by 53% since 1970 due to Habitat loss and degradation, over exploitation and Climate change.
- The report was based on Forest Specialist Index, which was developed based on the method for the **Living Planet Index (LPI)**, an indicator of global biodiversity.
- Diferrent species numbering around of 455 including birds, mammals, reptiles and amphibians were monitored in this report.
- It is stated in the report that during 1970 to 2014 species declined at an annual rate of 1.7 %, on average and this resulted that only 268 species were available.



• In a bid to conserve nature, world leaders have agreed to launch a New Deal for Nature and People in 2020 in China.

### Indications from the report:

- 60 % of threats accounted from Habitat loss.
- 40 out of 112 forest-dwelling primate populations threatened due to over exploitation.
- 43% amphibian creatures, 37 % of reptiles and 21 % of birds were threatened due to Climate change.
- It has also been indicated by the report that major decline is among mammals, reptiles, and amphibians (particularly from the tropical forests), it was less among birds, especially from temperate forests.

## The first Indian to win a Badminton World Championships gold

- P.V. Sindhu on August 25, 2019 became the first Indian to win a Badminton World Championships gold by beating familiar rival Nozomi Okuhara of Japan in a lop-sided final here.
- The Indian won 21-7 21-7 in the summit clash that lasted just 38 minutes.
- Two years after being robbed off the gold by Okuhara in an epic 110-minute final at Glasgow that went down as one of the greatest battles in badminton history, Sindhu finally exorcised the ghost of that heart-wrenching loss with a completely dominating win over the same opponent.
- It was Sindhu's fifth World Championships medal joint most for a woman singles player with former Olympics and world champion Zhang Ning of China to go with the two successive silvers and a couple of bronze medals.
- Sindhu has also won an Olympic silver in 2016 Rio Games, silver at Gold Coast Commonwealth Games, an Asian Games silver at Jakarta and the BWF World Tour Finals in 2018.
- Badminton Association of India announced a cash reward of Rs 20 lakh and Rs 5 lakh for PV Sindhu and Sai Praneeth for their historic feats in the World Championships in Basel, Switzerland.
- "BAI President @himantabiswa announces cash award of ₹20 lakh for World Champion @Pvsindhu1 and ₹5 lakh for @saiprneeth92 for their historic performance at the #bwfworldchampionship2019," tweeted BAI.
- While Sindhu became the first Indian to win a World Championships gold, Praneeth ended a 36-year wait after Prakash Padukone's feat to secure a bronze for the country in men's singles.

### BWF championship:

- The BWF World Championships (formerly known as IBF World Championships, also known as the World Badminton Championships) is a badminton tournament sanctioned by Badminton World Federation (BWF).
- The tournament offers the most ranking points, together with Summer Olympic Games. The winners will be crowned as the "World Champions" and awarded gold medals. However, it does not offer any prize money.

- She was senior leader of Bhartiya Janata Party. She was elected seven times as a Member of Parliament and three times as a Member of the Legislative Assembly.
- Swaraj served as the Minister of External Affairs of India in the first Narendra Modi government (2014 – 2019).
- Also, she was the second woman to hold the portfolio of External Affairs Minister, after Indira Gandhi.
- She served as Member of Parliament from Vidisha constituency (2009-2019) in the Indian state of Madhya Pradesh.

- At the age of 25 in 1977, she became the youngest cabinet minister in the Janata Party Government headed by then Chief Minister Devi Lal in the Indian State of Haryana. She won the Legislative Assembly election from Ambala Cantonment constituency.
- She was Education Minister of Haryana state in the Bharatiya Janata Party-Lok Dal coalition government during the period of 1987 to 1990.
- In October 1998 she resigned from the Union Cabinet to take over as the first female Chief Minister of Delhi (5th CM of Delhi ) for a short duration.
- She was Minister of Health, Family Welfare and Parliamentary Affairs from January 2003 until May 2004 in Atal Bihari Vajpayee government.
- As Union Health Minister, she set up six All India Institute of Medical Sciences at Bhopal (MP), Bhubaneshwar (Odisha), Jodhpur (Rajasthan), Patna (Bihar), Raipur (Chhattisgarh) and Rishikesh (Uttrakhand).
- Sushma Swaraj became Leader of Opposition in the 15th Lok Sabha.
- She is the Indian Parliament's first and the only female MP honored with the Outstanding Parliamentarian Award.
- She decided not to contest the 2019 General Elections due to health reasons.



- Bandung formulated the concept of non-alignment based on the Third World desire not
  to become involved in the East-West ideological confrontation of the Cold War, and to
  focus instead on national independence struggles, the alleviation of poverty, and
  economic development. These principles were adopted at the founding non-aligned
  summit in Belgrade in 1961.
- Whereas NAM started with 25 members in 1961, it has now expanded to 115 developing member countries which constitute nearly two-thirds of the United Nations.
- The First NAM Summit Conference took place in Belgrade, Yugoslavia, in September 1961.
- In 2018 the Non-Aligned Movement Summit was held in Baku city of Azerbaijan.

Parliament passes POCSO Bill, 2019

- Lok Sabha passed The Protection of Children from Sexual Offences (Amendment) Bill, 2019 on 1st of August, 2019.
- The bill seeks to enhance punishment, including a provision for death penalty, for committing sexual crimes against children.
- This bill was introduced by the Women and Child Development Minister Smriti Irani.
- Earlier The Protection of Children from Sexual Offences (Amendment) Bill, 2019 was introduced in Lok Sabha by the Minister of State for Women and Child Development, Mr. Virendra Kumar on January 8, 2019.

### **Salient Features of Amendment Bill**

- The Bill defines child pornography so that sexual predators indulging in such heinous crimes could be punished.
- The Bill would provide legal protection to 39 per cent of population or 43 crore children, irrespective of whether they are a girl or boy.
- Under witness protection scheme, all measures such as doing threat assessment of the victim and witness and if required even changing their identity and others, were taken to ensure their safety.
- If juvenile is involved in the sexual offence against the children, the cases come under juvenile justice act and the death penalty could be given only if he is above 16 years of age and juvenile justice board finds that he has an adult mind.
- The government has sanctioned 1023 fast track courts, which would specially deal with POCSO related cases.
- The Protection of Children from Sexual Offences (Amendment) Bill, 2019 was introduced in Lok Sabha by the Minister of State for Women and Child Development, Mr. Virendra Kumar on January 8, 2019.

- Parliament passed Unlawful Activities (Prevention) amendment Act, 2019 on August 2, 2019 after the passage of the UAPA amendment bill, 2019 form the Rajya Sabha with a 147-42 majority.
- The Unlawful Activities (prevention) amendment bill 2019 was introduced in Lok Sabha by the Minister of home Affairs, Mr. Amit Shah, on July 8, 2019.
- Lok Sabha passed this bill which will amend the Unlawful Activities (prevention) Act 1967.

### Provisions added in the proposed amendment:

- Who may Commits, participate, promotes, prepares or is otherwise involved in the Terrorism will now be tagged as terrorist without FIR, chargesheet or trial.
- Officer of NIA has to take prior approval from DGP for investigation or to seize the property
- Now an officer above the rank of inspector can investigate the matter.
- Act defines terrorist to include acts committed within the scope of any of the nine treaties listed in a schedule of the act.
- These nine treaties also include the convention for suppression of terrorist bombings (1997), and convention against Taking of hostages (1979).

 This act adds another treaty, the International Convention for Suppression of Acts of Nuclear Terrorism (2005).

- There is no defined age for organ donation but it is based on a strict medical criteria.
- If someone younger than the age of 18 wants to donate organ then he or she must have an agreement of parents or guardian.
- In the case of natural death tissues of cornea, heart valves, bone and skin can be donated whereas other vital organs like heart, liver, intestines, kidneys, lungs, and pancreas can only be donated in the case of brain death.
- Anyone can be an organ donor irrespective of age, caste, religion, community etc.
