ISRO Launched 104 Satellites in a Single Flight



Related Fact

 On 15th February, 2017 ISRO's Polar Satellite Launch Vehicle (PSLV-C37) successfully launched the 714 kg Cartosat-2 Series Satellite along with 103 co-passenger satellites from Satish Dhawan Space Centre, Sriharikota.



- PSLV-C37 lifted off at 9:28 am IST, as planned, from the First Launch Pad.
- The satellites achieved a polar Sun Synchronous Orbit of 506 km inclined at an angle of 97.46 degree to the equator after a flight of 16 minutes 48 seconds.
- This is the thirty ninth flight of Polar Satellite Launch Vehicle and thirty eighth consecutively successful mission of PSLV.
- The total weight of all the 104 satellites carried on-board PSLV-C37 was 1378 kg.
- The total number of Indian satellites launched by PSLV now stands at 46.
- The satellite will be brought to its final operational configuration in the coming days following which it will begin to provide remote sensing services using its panchromatic (black and white) and multispectral (colour) cameras.
- Of the 103 co-passenger satellites carried by PSLV-C37, two ISRO Nano Satellite INS-1 and INS-2 are technology demonstration satellites from India.
- The remaining 101 co-passenger satellites carried were international customer satellites from USA (96), The Netherlands (1), Switzerland (1), Israel (1), Kazakhstan (1) and UAE (1).
- With today's successful launch, the total number of customer satellites from abroad launched by PSLV has reached 180.



- On 17 February 2017; the National Regulatory Authority of India (NRA) and affiliated institutions meet the WHO Global Benchmarking Tool requirements for a functional vaccine regulatory system.
- A World Health Organization (WHO) led team of international experts from several countries came to this conclusion at the end of a comprehensive review from 13-17 February 2017.
- Affiliated institutions includes, Central Drugs Standards Control Organization (CDSCO);
 Central Drugs Laboratory, Kasauli; Pharmaco-vigilance Programme and Immunization
 Division, and other relevant institutions engaged in the regulation, control and testing of vaccines.
- One of the requirements to become eligible and retain the prequalification status is to have the NRA assessed as functional against the WHO Global Benchmarking Tool.
- Safety, efficacy and quality are three basic parameters of assessment of vaccines.

- This can be used for communication equipment, battery charging and general lightings onboard round the clock with battery outputs during night.
- This power source can be used at sea as well as in harbour.
- This green initiative of the Indian Navy saves approximately 89.1 kg of carbon emission per day when compared with a diesel generator.

- The company was jointly promoted by the Government of Gujarat and the Gujarat State Fertilizer Company Limited (GSFC).

- The 11th edition of International Aerospace and Defence Exhibition Aero India 2017 will be held at the Air Force Station, Yelahanka in Bengaluru from 14th to 18th February 2017.
- Aero India which began in 1996, has established itself as a premium aerospace and aviation exhibition in the international arena.
- It has become one of the most sought after exhibitions in the Asian region in terms of participation from across the globe.
- The event is being organized and conducted by the Defence Exhibition Organisation (DEO).
- The highlights of this year's show are:
- Participation from 270 Indian Companies and 279 foreign companies. That is a total of 549 companies.
- The total area of the show has grown from 24,403 sqm to 27,678 sqm this year.
- Number of aircraft participating are 72.
- The gross area has also increased from 2,50,000 sqm to 2,60,000 sqm.
- "Indian Aerospace : Investor's Meet" by CII
- "Make in India in Aerospace: Are MSMEs geared for it? Reflections and the Way Forward" – PHD, CII
- Round Tables Country specific by Indian Chambers (B2B)
- Indo-Swiss Business Meet
- A Business to Business meeting area has been created and is being offered to Indian business industries free of cost.
- Karnataka, Andhra Pradesh, Gujarat and Kerala are setting up exclusive SEZ pavilions for attracting investment.
- Confirmation has been received from 30 Countries and the process is still on. In total 65 delegates comprising Ministers of Defence, Service Chiefs, Heads of Department from Bahrain, Bangladesh, Brazil, Brunei, Cyprus, the Czech Republic, Egypt, France, Germany, Indonesia, Israel, Japan, Malaysia, Myanmar, Nepal, Nigeria, Oman, Seychelles, Sri Lanka, Sudan, South Africa, Sweden, Switzerland, Tanzania, Thailand, Turkey, the UAE, the UK, USA and Uzbekistan have confirmed their presence.

- There shall be country-wise company participation from 23 countries, including official delegations. A total of 51 countries are participating.
- Exhibitors from USA, France, the UK, Russia, Israel, Germany, Belgium, Switzerland, Ukraine, Singapore, Sweden, Spain, South Africa, Italy, the UAE, South Korea, Hong Kong, the Czech Republic, Canada, Australia, Poland and Greece will participate.
- Aerobatic teams participating in the show will be the Indian Air Force Sarang Team, the Indian Air Force Surya Kiran Team, the Scandinavian Air Show Team from Sweden and the Evolvkos Aerobatic Team from the UK.

Pradhan Mantri Gramin Digital Saksharta Abhiyan

Question: 'Pradhan Mantri Gramin Digital Saksharta Abhiyan' envisaged to spread digital literacy in rural India by March, 2019, would be implemented under the supervision of ...

- On 8th February, 2017, the Union Cabinet chaired by Prime Minister Narendra Modi approved 'Pradhan Mantri Gramin Digital Saksharta Abhiyan' (PMGDISHA) to make 6 crore rural households digitally literate.
- The outlay for this project is Rs.2,351.38 crore to usher in digital literacy in rural India by March, 2019. This is in line with the announcement made by Finance Minister in the Union Budget 2016-17.
- Under the scheme, 25 lakh candidates will be trained in the FY 2016-17; 275 lakh in the FY 2017-18; and 300 lakh in the FY 2018-19.
- To ensure equitable geographical reach, each of the 250,000 Gram Panchayats would be expected to register an average of 200-300 candidates.
- The implementation of the Scheme would be carried out under the overall supervision of Ministry of Electronics and IT in active collaboration with States/UTs through their designated State Implementing Agencies, District e-Governance Society etc.
- Background:

- As per the 71st NSSO Survey on Education 2014, only 6% of rural households have a computer. The PMGDISHA being initiated under Digital India Programme would cover 6 crore households in rural areas to make them digitally literate.
- This would empower the citizens by providing them access to information, knowledge and skills for operating computers / digital access devices.
- As the thrust of the Government is on cashless transactions through mobile phones, the
 course content would also have emphasis on Digital Wallets, Mobile Banking, Unified
 Payments Interface (UPI), Unstructured Supplementary Service Data (USSD) and
 Aadhaar Enabled Payment System (AEPS), etc.
- Benefit:
- Digitally literate persons would be able to operate computers/digital access devices (like tablets, smart phones, etc.), send and receive emails, browse internet, access
 Government Services, search for information, undertaking cashless transactions, etc.
- Therefore people would be able to use IT to actively participate in the process of nation building.

Payment of Wages Bill passed in the Parliament

- On 7th February, 2017, Parliament passed The Payment of Wages (Amendment) Bill
 2017
- The Payment of Wages (Amendment) Bill 2017 was passed by voice vote in Rajya Sabha on 7th February, 2017.
- The Lok Sabha had passed the bill on 6th February, 2017.
- This Bill seeks to enable the Centre and state governments to specify industrial units
 which will have to pay wages only either through cheques or by transferring into bank
 accounts.
- The bill replaces the Payment of Wages (Amendment) Bill 2016, which was introduced in Lok Sabha on December 15, 2016 and repeals the Payment of Wages (Amendment)
 Ordinance 2016 promulgated on December 28, 2016.

- Under the 1936 Act, all wages must be paid either in coin or currency notes, or both.
 However, the employer may pay his employee's wages either by cheque or by crediting it into his bank account, after obtaining his written authorisation.
- The Bill amends the 1936 Act to permit the employer to pay an employee's wages: (i) in coin or currency notes; or (ii) by cheque; or (iii) by crediting them into his bank account.
 The Bill removes the requirement of obtaining written authorisation for payment of wages by cheque or through a bank account.
- However, the relevant central or state government may specify certain industrial or other
 establishments where the employer should pay his employees only by: (i) cheque; or (ii)

- Indian Institutes of Management are the country's premier institutions imparting best quality education in management on globally benchmarked processes of education and training in management.
- IIMs are recognized as world-class management Institutions and Centers of Excellence and have brought laurels to the country.
- All IIMs are separate autonomous bodies registered under the Societies Act.
- Being societies, IIMs are not authorized to award degrees and, hence, they have been awarding Post Graduate Diploma and Fellow Programme in Management.
- While these awards are treated as equivalent to MBAs and Ph.D, respectively, the equivalence is not universally acceptable, especially for the Fellow Programme.

- On 15th February, 2017, The Heritage Foundation released the 2017 Index of Economic Freedom.
- Among the 180 countries ranked, scores improved for 103 countries and declined for 73 (16 of which recorded their lowest Index scores ever).
- Five economies earned the Index's designation of "free" (scores of 80 or above), while the next 87 are classified as "mostly free" (70-79.9) or "moderately free" (60-69.9). Yet

- the number of economically "unfree" economies remains high: 65 are considered "mostly unfree" (50-59.9) and 23 are "repressed" (scores below 50).
- Hong Kong and Singapore each logged increases in their Index scores, finishing first and second in the rankings for the 23rd consecutive year.
- Five other frequent top 10 finishers New Zealand (3rd globally), Switzerland (4th),
 Australia (5th), Estonia (6th) and Canada (7th) also improved their scores. A surprise
 newcomer to the top 10, the United Arab Emirates, improved its Index score by 4.3 points
 to take the 8th spot. Ireland (9th) and Chile (10th) saw their scores dip, but still managed
 to round out the global top 10.
- India ranked 143rd in the annual index of economic freedom and falls under 'mostly unfree' category with score of 52.6.
- India's score of 52.6 points is 3.6 points less than that of last year, when India was ranked 123rd.
- Nepal (125), Sri Lanka (112), Pakistan (141), Bhutan (107), and Bangladesh (128) surpassed India in economic freedom.
- China with a score of 57.4 points was placed at 111 positions. The United States was ranked 17 with 75.1 points.
- The world average score of 60.9 is the highest recorded in the 23-year history of the index.
- How it works:
- The Index evaluates countries in four broad policy areas that affect economic freedom:
 rule of law; government size; regulatory efficiency; and open markets. There are 12
 specific categories: property rights, judicial effectiveness, government integrity, tax
 burden, government spending, fiscal health, business freedom, labor freedom, monetary
 freedom, trade freedom, investment freedom, and financial freedom. Scores in these
 categories are averaged to create an overall score.
- Based on an average score, each of 180 countries graded in the 2017 Index is classified as "free" (i.e., combined scores of 80 or higher); "mostly free" (70-79.9); "moderately free" (60-69.9); "mostly unfree" (50-59.9); or "repressed" (under 50).
- The Index groups the world's countries into five regions: the Americas, Asia-Pacific (home to nine of the 20 most-improved countries), Europe, Middle East/North Africa and Sub-Saharan Africa (with the most countries recording notable score declines).

- The H-1B is a non-immigrant visa in the United States under the Immigration and Nationality Act, section 101(a)(15)(H).
- It allows U.S. employers to temporarily employ foreign workers in specialty occupations.
- If a foreign worker in H-1B status quits or is dismissed from the sponsoring employer, the
 worker must either apply for and be granted a change of status to another non-immigrant
 status.
- The biggest impact will be on the Indian IT companies.

- For this RRBs should maintain a Loan to Value (LTV) ratio of 75% on the outstanding amount of loan including the interest on an ongoing basis, failing which the loan will be treated as a Non Performing Asset (NPA).
- RBI has clarified that crop loans sanctioned against the collateral security of gold/gold ornaments shall continue to be governed by the extant income recognition, asset classification and provisioning norms for such loans.
- India's first RRB was established in 1975.
- These were set up on the recommendations of The M. Narasimham committee.

- As per Second Advance Estimates for 2016-17, total Foodgrain production in the country is estimated at 271.98 million tonnes which is higher by 6.94 million tonnes than the previous record production of Foodgrain of 265.04 million tonnes achieved during 2013-14.
- The current year's production is also higher by 14.97 million tonnes than the previous five years' (2011-12 to 2015-16) average production of Foodgrains.
- Total production of Rice is estimated at record 108.86 million tonnes which is also a new record.
- This year's Rice production is higher by 2.21 million tonnes than previous record production of 106.65 million tonnes achieved during 2013-14.
- It is also higher by 3.44 million tonnes than the five years' average Rice production of 105.42 million tonnes.
- Production of rice has increased significantly by 4.45 million tonnes than the production of 104.41 million tonnes during 2015-16.
- Production of Wheat, estimated at 96.64 million tonnes is also a record.
- This year's wheat production is higher than the previous record production of 95.85 million tonnes achieved during 2013-14.
- Production of Wheat during 2016-17 is also higher by 4.03 million tonnes than the average wheat production.
- The current year's production is higher by 4.36 million tonnes as compared to Wheat production of 92.29 million tonnes achieved during 2015-16.
- Production of Coarse Cereals estimated at a new record level of 44.34 million tonnes is higher than the average production by 3.00 million tonnes.
- It is higher than the previous record production of 43.40 million tonnes achieved during 2010-11 by 0.94 million tonnes.
- Current year's production it is also higher by 5.82 million tonnes as compared to their production of 38.52 million tonnes achieved during 2015-16.
- As a result of significant increase in the area coverage and productivity of all major
 Pulses, total production of pulses during 2016-17 is estimated at 22.14 million tonnes
 which is higher by 2.89 million tonnes than the previous record production of 19.25 million
 tonnes achieved during 2013-14.
- Production of Pulses during 2016-17 is also higher by 4.50 million tonnes than their Five years' average production.

- Current year's production is higher by 5.79 million tonnes than the previous year's production of 16.35 million tonnes.
- With an increase of 8.35 million tonnes over the previous year, total Oilseeds production in the country is estimated at record level of 33.60 million tonnes.
- It is higher by 0.85 million tonnes than the previous record production of 32.75 million tonnes achieved during 2013-14.
- Production of Sugarcane is estimated at 309.98 million tonnes which is lower by 38.46 million tonnes than the last year's production of 348.45 million tonnes.
- Despite lower area coverage during 2016-17, higher productivity of Cotton has resulted into higher production of 32.51 million bales (of 170 kg each) as compared to 30.01 million bales during 2015-16.
- Production of Jute & Mesta estimated at 10.06 million bales (of 180 kg each) is marginally lower than their production of 10.52 million bales during the last year.

- The Cabinet also approved the introduction of a Bill in Parliament to repeal the State Bank of India (Subsidiary Banks) Act, 1959 and the State Bank of Hyderabad Act, 1956.
- The merger is likely to result in recurring savings, estimated at more than Rs. 1,000 crore in the first year, through a combination of enhanced operational efficiency and reduced cost of funds.
- The acquisition of subsidiary banks of State Bank is an important step towards strengthening the banking sector through consolidation of public sector banks.
- It is in pursuance of the Indradhanush action plan of the Government and it is expected to strengthen the banking sector and improve its efficiency and profitability.
- It is to be noted that Indradhanush Action Plan is a 7-pronged strategy to address the challenges in public sector banking system.
- Benefit:
- The acquisition under Section 35 of the State Bank of India Act, 1955 will result in the creation of a stronger merged entity.
- It will create improved operational efficiency and economies of scale.
- It will also result in improved risk management and unified treasury operations.
- Existing customers of subsidiary banks will benefit from access to SBI's global network.
- The merger will also lead to better management of high value credit exposures through focused monitoring and control over cash flows.

- During January, 2017 exports grew at 4.32 per cent in dollar terms (valued at US\$ 22115.03 million) and 5.61 per cent in Rupee terms (valued at Rs. 150559.98 crore) as compared to US\$ 21199.02 million (Rs. 142568.31 crore) during January, 2016.
- Cumulative value of exports for the period April-January 2016-17 was US\$ 220922.78 million (Rs. 1484473.55 crore) as against US\$ 218532.64 million (Rs. 1420572.68 crore) registering a positive growth of 1.09 per cent in Dollar terms and positive growth of 4.50 per cent in Rupee terms over the same period last year.
- Non-petroleum exports in January 2017 were valued at US\$ 19422.86 million against
 US\$ 19111.38 million in January 2016, an increase of 1.6 %. Non-petroleum exports
 during April January 2016-17 were valued at US\$ 196254.10 million as compared to
 US\$ 192071.50 million for the corresponding period in 2016, an increase of 2.2%.
- The growth in exports is positive for USA (2.63%), EU(5.47%) and Japan(13.43%) but China has exhibited negative growth of (-1.51%) for November 2016 over the corresponding period of previous year as per latest WTO statistics.

IMPORTS:

- Imports during January 2017 were valued at US\$ 31955.94 million (Rs. 217557.32 crore) which was 10.70 per cent higher in Dollar terms and 12.07 per cent higher in Rupee terms over the level of imports valued at US\$ 28866.53 million (Rs. 194134.02 crore) in January, 2016.
- Cumulative value of imports for the period April-January 2016-17 was US\$ 307311.86 million (Rs. 2065656.42 crore) as against US\$ 326277.38 million (Rs. 2120158.57 crore) registering a negative growth of 5.81 per cent in Dollar terms and 2.57 per cent in Rupee terms over the same period last year
- Oil imports during January, 2017 were valued at US\$ 8140.83 million which was 61.07 percent higher than oil imports valued at US\$ 5054.29 million in January 2016

- Oil imports during April-January, 2016-17 were valued at US\$ 69062.66 million which
 was 5.81 per cent lower than the oil imports of US\$ 73321.66 million in the corresponding
 period last year.
- Non-oil imports during January, 2017 were estimated at US\$ 23815.11 million which was
 0.01 per cent higher than non-oil imports of US\$ 23812.24 million in January, 2016.
- Non-oil imports during April-January 2016-17 were valued at US\$ 238249.20 million which was 5.81 per cent lower than the level of such imports valued at US\$ 252955.72 million in April-January, 2015-16.

First State to establish Cashless System for distribution of food grains

- Background:
- In January this year, Union Food Minister Ram Vilas Paswan had organized a meeting with state food ministers for establishing cashless system in the PDS across the country.
- Majority of states agreed to provide cash less distribution system of food grains by March 31.
- Benefits:
- According to the Food ministry there are over 81 crore beneficiaries under National Food Security Act in the country.
- This will help in establishing the identity of beneficiaries, help in stopping the leakages of grains at shop level and above all eradicate corruption in the PDS.
- The Gujarat government has partnered with common service centres, a special purpose vehicle of ministry of Electronics and IT by offering 30 digital services through the FPSs like Rail Ticket reservation, mobile bill payment, payment of crop insurance and LIC premiums etc.
- Further, a farmer can get the soil health card and registration for centrally sponsored schemes

ISRO Successfully Tests its Cryogenic Stage for GSLV Mk-III rocket

Question: Recently the Indian Space Research Organisation (ISRO) successfully tested its indigenously developed Cryogenic Upper Stage (CUS) for GSLV MkIII on February 17, 2017. The cryogenic stage designated as-

Related facts:

- On 17 February 2017; Indian Space Research Organisation (ISRO) successfully tested its indigenously developed Cryogenic Upper Stage (CUS) for GSLV MkIII rocket.
- The cryogenic stage designated as C25.
- It was tested for flight duration of 640 seconds at ISRO Propulsion Complex (IPRC) in Mahendragiri, Tamil Nadu.
- It should be known that C25 Stage had earlier been tested successfully for 50 seconds on January 25, 2017 to validate all the systems.
- Prior to Stage development hot tests, three CE20 engines were realised and two engines were subjected to qualification tests in sea level conditions.
- This included 800 seconds duration hot test and the third engine identified for flight was tested in high.
- The C25 stage is the most powerful upper stage developed by ISRO and uses Liquid Oxygen (LOX) and Liquid Hydrogen (LH2) propellant combination.

- The stage carries 27.8 tons of propellants loaded in two independent tanks. Development of a cryogenic stage has unique design challenges, with liquid Hydrogen stored at -253 deg C and liquid Oxygen stored at -195 deg C in its tanks.
- To store these cryogenic fluids, special multi-layer insulation is provided for the tanks and other structures.
- The development of the cryogenic stage was led by Liquid Propulsion Systems Centre (LPSC) with support from various System Development Agencies from other ISRO Centres of ISRO, viz., Vikram Sarabhai Space Centre (VSSC), ISRO Propulsion Complex (IPRC) and Sathish Dhawan Space Centre (SDSC), SHAR.
- The Cryogenic Stage development tests were carried out in two phases.
- First, the Stage was subjected to fluid mock-up, wherein the stage preparation and servicing at launch complex in SDSC, SHAR, Sriharikota was completed to prove all the ground facilities established for servicing the cryogenic stage.
- Second phase used for testing of the Stage at ISRO Propulsion Complex, Mahendragiri.
 From the Stage realisation to completion of testing was accomplished in four months.
- The flight cryogenic stage is in advanced stage of realisation, and forms the upper stage
 of GSLV Mk-III the next generation launch vehicle of ISRO, capable of launching 4 ton
 class satellites into Geosynchronous Transfer Orbit (GTO).
- The vehicle consists of two solid strap-ons (S200) motors, one earth storable liquid core stage (L110) and the Cryogenic Upper Stage (C25).
- The GSLV MkIII vehicle integration activities are in progress at SDSC, SHAR for its first development flight (GSLV MkIII-D1) targeted for April 2017.

- The draft rules were operationalised in October even as FSSAI sought comments from stakeholders before finalising the final regulations.
- Standards have been set for fortification of salt with iodine and iron; of vegetable oil and milk with vitamin A and D; wheat flour and rice with iron, folic acid, zinc, vitamin B12, vitamin A and some other micro nutrients
- Fortification is the addition of key vitamins and minerals such as iron, iodine, zinc, Vitamin
 A & D to staple foods such as rice, milk and salt to improve their nutritional content.
 These nutrients may or may not have been originally present in the food before
 processing.

- According to a press release issued by Ministry of Law & Justice dated 16th February, 2017,
 Supreme Court of India has introduced the Middle Income Group Scheme.
- It is a self supporting scheme which provides legal services to the middle income group citizens i.e. citizens whose gross income is not exceeding Rs.60, 000 per month or Rs. 7, 50, 000 per annum.
- The members of the governing body to whom the management of the Society is entrusted as required under Section 2 of the Societies Registration Act, 1860, includes Hon'ble Chief Justice of India as Patron-in-Chief, Attorney General for India as Ex-officio Vice-President, Solicitor General of India as Honorary Secretary and other senior advocates of the Apex Court as its members.

Provisions of the Scheme:

• As per the Supreme Court rules it is only through advocates on record cases can be filed before it.

- A sum of Rs.500/- shall be payable to the Supreme Court Middle Income Group Legal Aid Society (SCMIGLAS) as service charges.
- It is the Secretary, who will register the case under the MIG Legal Aid Scheme and proceed to forward the papers to the Advocate-on-Record/Arguing Counsel/Senior Counsel on the panel for opinion.
- If Advocate-on-Record is satisfied that it is a fit case to be proceeded with, then the Society will consider that the applicant is entitled to legal aid. The view expressed by the Learned Advocate-on Record will be final insofar as the eligibility of the applicant for obtaining the benefit of the Scheme is concerned.
- In case the advocate thinks that the case is not fit one for an appeal to the Supreme Court, then the entire amount after deduction Rs.750/- towards minimum service charges of the Committee shall be refunded to the applicant by way of cheque.
- If the Advocate appointed under the Scheme is found negligent in the conduct of the case, then he will be required to return the brief together with the fee which he may have received from the applicant under the scheme.
- However, the Society will not be responsible for the negligent conduct of the case but the entire responsibility will be that of the Advocate vis-a-vis the client. The name of the Advocate will, however, be struck off from the panel prepared under the Scheme.

Benefits:

Under the scheme, middle class people who can't afford the expensive litigation in the Supreme Court can avail the services of the society for a nominal amount. The person desirous of availing the benefit of the Scheme shall have to fill up the form prescribed and accept all the terms and conditions. A large number of poor people would approach the Supreme Court for aid to sort out their cases, file cases on their behalf and get justice. This scheme will make filing petitions easy for the underprivileged strata of the society.

- MR vaccine will be provided free- of- cost across the states from session sites at schools as well as health facilities and outreach session sites.
- Measles is a deadly disease and one of the important causes of death in children. It is highly contagious and spreads through coughing and sneezing of an infected person.
- Rubella is generally a mild infection, but has serious consequences if infection occurs in pregnant women, causing congenital rubella syndrome (CRS), which is a cause of public health concern.
- In 2010, an estimated 1,03,000 children were born with CRS (congenital rubella syndrome) globally, of which around 47,000 children.
- Globally, in 2015, measles killed an estimated 1, 34,200 children—mostly under-5 years. In India, it killed an estimated 49,200 children.

 Income-tax Act in 2012 and the "Rollback" provisions were introduced in 2014.
- An advance pricing agreement (APA) is an ahead-of-time agreement between a taxpayer and a tax authority on an appropriate transfer pricing methodology (TPM) for a set of transactions at issue over a fixed period of time.
- The scheme endeavors to provide certainty to taxpayers in the domain of transfer pricing by specifying the methods of pricing and determining the prices of international transactions in advance.
- Since its inception, the APA scheme has evinced a lot of interest from taxpayers and that
 has resulted in more than 700 applications (both unilateral and bilateral) being filed so far
 in about five years.
- The progress of the APA Scheme strengthens the Government's resolve of fostering a non-adversarial tax regime. The Indian APA program has been appreciated nationally and internationally for being able to address complex transfer pricing issues in a fair and transparent manner.

 Court issued contempt of court notice against sitting Calcutta HC judge C.S. Karnan for

 country by writing scurrilous letters about sitting and retired judges.
- The Bench, led by Chief Justice of India J.S. Khehar, ordered Justice Karnan to appear in person before it on February 13 to show cause to the court why contempt proceedings should not be taken against him.
- The Bench comprised Justices Dipak Misra, J. Chelameswar, Ranjan Gogoi, Madan B. Lokur, P.C. Ghose and Kurian Joseph.
- The Bench directed Justice Karnan to forthwith refrain from undertaking any judicial or administrative work and return all his official files to the Calcutta HC Registry.
- Supreme Court as the apex judiciary is empowered under Articles 129 read with its
 extraordinary powers under Article 142 (2) to punish a member of the High Court and
 subordinate judiciary for contempt.
- This is the first time in judicial history that Supreme Court has issued contempt notice to a sitting Calcutta High Court Judge.

• Background:

According to WHO, Soil-Transmitted Helminths (STH) or parasitic worms are among the
most common infections worldwide. It lives in human intestines and consume nutrients
meant for the human body. India has the highest burden of Soil-Transmitted Helminths in
the world, with 220 million children aged 1-14 estimated to be at risk of worm infections.
Almost 7 in 10 children between 6 month and 5 years are anaemic, with even higher
rates of anaemia in rural areas, as per the 2006 National Family Health Survey.

• Deworming tablet:

• Children at the age of (1-2) are given half a tablet of albendazole (400mg), and above the age of 2 are given 1 full tablet of albendazole (400mg) to chew. Albendazole is very safe and has very few side effects and it occurs with mild side effects like nausea and diarrhea and passes quickly.

- This year World Wetland Day is being celebrated in collaboration with the Government of Madhya Pradesh at Bhoj Wetlands, Bhopal, which is one of the 26 Ramsar sites that India has designated under the Ramsar Convention.
- The theme of World Wetlands Day for 2017 is 'Wetlands for Disaster Risk Reduction'.
 This theme has been selected to raise awareness on the vital roles of healthy wetlands in reducing the impacts of extreme events on communities and in helping to build resilience.
- The National Biodiversity Authority (NBA), Chennai, under the Ministry of Environ and Forest, has planned two events to spread public awareness about conservation of Wetlands. The first is a radio-outreach and awareness generation campaign and second a school outreach programme.

Importance of Wetlands:

- Wetlands support human well-being in a number of ways. As 'kidneys of landscape', wetlands receive flows of water and waste from upstream sources. They help stabilize water supplies, cleanse polluted waters, protect shorelines and recharge groundwater aquifers.
- Wetlands are our natural buffers against increasing risk of floods, droughts and tropical cyclones. Wetlands can act as sponges, storing peak rainfall and releasing water gradually during lean season.



- The floods in Kashmir Valley in September, 2014 and Chennai city in December, 2015 are reminders of the ways wetland destruction can make lives vulnerable.
- Super Cyclone Kalinga of 1999, Indian Ocean Tsunami of 2004 and Phailin of 2013 underline the role coastal wetlands can play in buffering communities from impacts of these cyclones and wave surges.
- Wetland convention and India:
- India is a party to the Convention since 1982 and committed to the Ramsar approach of wise use of wetlands.
- The Ministry of Environment and Forest accords high priority to wetlands conservation, and has a dedicated scheme of 'National Plan for Conservation of Aquatic Ecosystems' (NPCA) to support State Governments in integrated management of these ecosystems.
 Till date, over 170 wetlands have been covered under the programme.
- The Ministry has also introduced Wetlands (Conservation and Management) Rules, 2010 as the regulatory framework for conserving wetlands of the country.

- It was restored and given a special spot in the newly built National Rail Museum at Chanakyapuri, in New Delhi which was opened to public 40 years back on 1st February, 1977.
- It was certified by the Guinness Book of Records in 1998 as the world's oldest steam locomotive in regular operation. The following year, the train received a National Tourism Award for the most innovative and unique tourism project.

- It should be known that some websites and mobile apps were luring citizens to share their basic information and Aadhaar number under the pretext of getting them Aadhaar card or offering other Aadhaar related services.
- At present, any Aadhaar-related demographic information can only be shared following the procedures laid down in the Aadhaar Act, 2016.
- Any violation is punishable under Section 38 and Chapter VII of the Aadhaar Act that
 provides punishment for "Whoever, not being authorised by the Authority, intentionally
 accesses or secures, downloads, copies or extracts any data from the Central Identities
 Data Repository or stored in any removable storage medium.
- These illegal websites and mobile applications (downloadable through Google Playstore)
 were providing unauthorised Aadhaar-related services such as downloading online
 Aadhaar card, providing the status of Aadhaar generation, PVC (plastic) Aadhaar Card,
 to residents. In the process, these agencies were illegally obtaining the Aadhaar number
 and enrolment details from the residents.
- It should be noted that UIDAI has not authorised the owners of these mobile applications or websites to extend any Aadhaar-related services on its behalf.
- Www.Uidai.Gov.In is the only authorised website of UIDAI.
- The Unique Identification Authority of India (UIDAI) is a central government agency of India.
- Its objective is to collect the biometric and demographic data of residents, store them in a centralised database, and issue a 12-digit unique identity number called Aadhaar to each resident.
- It is considered the world's largest national identification number project.
