- The 2020 Nobel Prize in Economic Sciences was awarded jointly to American Economists Paul R. Milgrom and Robert B. Wilson.
- They have been awarded for improvements to auction theory and inventions of new auction formats benefitting sellers, buyers and taxpayers around the world.
- They have not just clarified how auctions work and why bidders behave in a certain way, but used their theoretical discoveries to invent entirely new auction formats for the sale of goods and services.
- Both economists are affiliated to Stanford University in California.

**About the Award:**

- Technically known as the Sveriges Riksbank Prize in Economic Sciences in Memory of Alfred Nobel, the prize was firstly awarded to Ragnar Frisch and Jan Tinbergen in 1969.

- In 2019, the WFP provided assistance to close to 100 million people in 88 countries who are victims of acute food insecurity and hunger.
- In 2015, eradicating hunger was adopted as one of the UN's Sustainable Development Goals. The WFP is the UN's primary instrument for realising this goal.

• **Context:**

- American poet Louise Glück won the 2020 Nobel Literature Prize on October 8, an unexpected choice known for themes of childhood and family life that draw inspiration from myths and classical motifs.

• **Facts:**

- In the year 1968, Glück made her debut with *Firstborn* and soon rose as one of the most prominent poets in American contemporary literature.
- She has so far published 12 collections of poetry and some essays.
- Glück is often regarded as an autobiographical poet.
- 4- She in her poetries self listens for what is left of its dreams and delusions, and nobody can be harder than she in confronting the illusions of the self.
- She draws inspirations from myths, personal experiences and classical motifs, which are present in her works.
- She has highlighted the aspects of trauma, desire, and nature in her works. Her poetries are known for their frank expressions of sadness and isolation.
- Louise Glück was born on April 22, 1943 in New York, New York City, US. She is an American poet and essayist. She is a professor of English at Yale University, Connecticut.
- She is known for *The Triumph of Achilles* (1985) and *The Wild Iris* (1992). She has received many awards including Pulitzer Prize for Poetry (1993), Bollingen Prize (2001), US Poet Laureate (2003–2004), National Book Award (2014) and National Humanities Medal (2015).

## Nobel Prize in Medicine 2020

**Question:** The 2020 Nobel Prize for Medicine or Physiology has been awarded for the discovery of:

• **Context:**

- The 2020 Nobel Prize for Medicine or Physiology has been awarded to Americans Harvey J Alter and Charles M Rice and British scientist Michael Houghton for the discovery of the Hepatitis C virus.
- **Facts:**
- The prestigious award comes with a gold medal and prize money of 10 million Swedish kronor (over \$1,118,000), courtesy of a bequest left 124 years ago by the prize's creator, Swedish inventor Alfred Nobel.
- The World Health Organisation estimates there are over 70 million cases of hepatitis worldwide and 400,000 deaths each year. The disease is chronic and a major cause of liver inflammation and cancer.
- The medicine prize carries particular significance this year due to the coronavirus pandemic, which has highlighted the importance that medical research has for societies and economies around the world.
- **Hepatitis C:**
- It is a liver disease caused by the hepatitis C virus (HCV): the virus can cause both acute and chronic hepatitis, ranging in severity from a mild illness lasting a few weeks to a serious, lifelong illness.
- Spread: The hepatitis C virus is a bloodborne virus: the most common modes of infection are through exposure to small quantities of blood. This may happen through injection drug use, unsafe injection practices, unsafe health care, transfusion of unscreened blood and blood products, and sexual practices that lead to exposure to blood.
- Cases of Hepatitis C: According to WHO, about 71 million people (6 -11 million of them in India) have chronic infection with the Hepatitis C virus which also happens to be a major cause of liver cancer.
- How is Hepatitis C treated? Presently there is no vaccine available for HCV. However, it can be treated with antiviral medication.
- **Additional Facts:**
- Hepatitis: It is an inflammation of the liver. The condition can be self-limiting or can progress to fibrosis (scarring), cirrhosis or liver cancer.
- Types of Hepatitis: There are 5 main hepatitis viruses referred to as types A, B, C, D and E.
- Hepatitis A and E are typically caused by ingestion of contaminated food or water.
- Hepatitis B, C and D usually occur as a result of parenteral contact with infected body fluids such as contaminated blood or blood products, invasive blood procedures using contaminated equipment.
- Hepatitis B transmission can also happen from mother to baby at birth, from family member to child and also by sexual contact.

## Nobel Prize in Physics 2020

- Context:

- Nobel Prize in Physics 2020 has been awarded, with one half to Roger Penrose and the other half jointly to Reinhard Genzel and Andrea Ghez for their discoveries about Black hole.
- Facts:
- Roger Penrose used ingenious mathematical methods in his proof that black holes are a direct consequence of Albert Einstein's general theory of relativity.
- Einstein did not himself believe that black holes really exist, these super-heavyweight monsters that capture everything that enters them. Nothing can escape, not even light.
- Reinhard Genzel and Andrea Ghez each lead a group of astronomers that, since the early 1990s, has focused on a region called Sagittarius A\* at the centre of our galaxy.
- Their pioneering work has given us the most convincing evidence yet of a supermassive black hole at the centre of the Milky Way.
- Black Hole:
- A black hole is a region of space from which nothing, not even light, can escape. These black holes consist a huge amount of matter packed densely into a small area, giving it an immense gravitational pull.
- Black holes are thought to be formed when very massive stars collapse at the end of their life cycle.
- In 2019, the first ever image of a black hole was taken by the Event Horizon telescope (ETH). The ETH is a project comprised of eight different telescopes at different observatories around the world.
- Additional Facts:
- Dr. Ghez is only the fourth woman to win the Nobel Prize in Physics, following Marie Curie in 1903, Maria Goeppert Mayer in 1963 and Donna Strickland in 2018.

## Nobel Prize in Chemistry 2020

- **Context:**
- Emmanuelle Charpentier of France and Jennifer Doudna of the U.S. won the Nobel Chemistry Prize for the gene-editing technique known as the CRISPR-Cas9 DNA snipping "scissors", the first time a Nobel science prize has gone to a women-only team.
- **Facts:**
- Charpentier, 51, and Ms. Doudna, 56, are just the sixth and seventh women to receive the Nobel Prize in Chemistry.
- Using the tool, "researchers can change the DNA of animals, plants and microorganisms with extremely high precision".
- The CRISPR-Cas9 tool has already contributed to significant gains in crop resilience, altering their genetic code to better withstand drought and pests.

- The technology has also led to innovative cancer treatments, and many experts hope it could one day make inherited diseases curable through gene manipulation.
- CRISPR's relative simplicity and widespread applicability has, however, triggered the imaginations of rogue practitioners. In 2018 in China, scientist He Jiankui caused an international scandal when he used CRISPR to create what he called the first gene-edited humans.
- **CRISPR (CaS9):**
- It stands for Clustered Regularly Interspaced Short Palindromic Repeats (CRISPR)
- It is a gene editing technology, which replicates natural defence mechanisms in bacteria to fight virus attacks, using a special protein called Cas9.
- The technology behaves like a cut-and-paste mechanism on DNA strands that contain genetic information.
- The specific location of the genetic codes that need to be changed, or "edited", is identified on the DNA strand and then using the Cas9 protein, which acts like a pair of scissors, that location is cut off from the strand. A DNA strand, when broken, has a natural tendency to repair itself.
- Scientists intervene during this an auto-repair process, supplying the desired sequence of genetic codes that binds itself with the broken DNA strand.
- **Gene Editing:**
- It is the deliberate alteration of a selected DNA sequence in a living cell. It involves editing an organism's DNA by altering, removing or adding nucleotides to the genome.

**Sand Dune Park**

- It will be India's first sand dune park.
- This project is proposed by the Goa State Biodiversity Board (GSBB).
- Park was first conceived by Antonio Mascarenhas, a former scientist at NIO (National Institute of Oceanography) & former member of GSBB. He will now act as the principal investigator for the project.

**Significance**

- Sand dunes play important role in phenomena like tsunami, tall waves, storms or high winds.
- These are geomorphic structures that are important for maintaining the integrity of the coast.

## Uttarakhand's first Ramsar Site

**Related Facts:-**

- On 15 October 2020; Ministry of Environment, Forest and Climate Change announced that Asan Conservation Reserve has become Uttarakhand's first Ramsar site.
- The Reserve is located on the banks of Yamuna River near Dehradun district in Garhwali region of the Himalayan state.
- With this declaration, this reserve became the Wetland of International Importance.
- With this, the number of Ramsar sites in India goes up to 38, the highest in South Asia and Uttarakhand gets its first Ramsar site.
- Asan Conservation Reserve cleared five out of the nine criteria needed to be declared as a Ramsar site and get identified as a Wetland of International Importance.
- It cleared the category on species and ecological communities, one on water-birds and another on fish.
- **The criteria cleared by Asan Conservation Reserve to get Ramsar site tag to include that-**

- i. It supports vulnerable, endangered, or critically endangered species.
- ii. It supports populations of plant and/or animal species important for maintaining the biological diversity,
- iii. It supports plant and/or animal species at a critical stage in their life cycles and-
- iv. It is an important source of food for fishes, spawning ground, nursery and/or migration path on which fish stocks, either within the wetland or elsewhere, depend.

- **Ramsar Convention on Wetlands**

- Ramsar Convention on Wetlands is an intergovernmental treaty adopted on February 2, 1971 in the Iranian city of Ramsar.
- The name of the Convention is usually written Convention on Wetlands.
- The Convention on Wetlands came into force for India on February 1, 1982.
- Those wetlands which are of international importance are declared as Ramsar sites.
- **Asan Conservation Reserve:**
- Asan Conservation reserve is spread across 4.44 sq km area in Dehradun district on the banks of Yamuna River.

- Asan receives about 40 migratory species, including Rudy Shelduck, Common coot, Gadwall, Kingfisher, Indian cormorant, Baer's pochard, Northern pintail, Bar-headed goose.
- Many endangered birds are found here and some even migrate to the Reserve, making it an ecologically important site.

- PM Modi launched Kisan Suryodaya Yojana to provide day-time power supply for irrigation to farmers.
- Under this scheme, farmers can avail electricity from 5 am to 9pm.
- A budget of Rs.3500 crore has been allocated for installing transmission infrastructure under this scheme by 2023.
- 234 '66-Kilowatt' transmission lines, with a total length of 3490 circuit kilometers (CKM) will be established under the project, in addition to 220 KV substations.
- Dahod, Patan, Mahisagar, Panchmahal, Chhota Udepur, Kheda, Tapi, Valsad, Anand and Gir-Somnath have been included under the Scheme for 2020-21. The remaining districts will be covered in a phase-wise manner by 2022-23.

## **Paediatric Heart Hospital attached with the U.N Mehta Institute of Cardiology and Research:**

- Prime Minister also inaugurated the Paediatric Heart Hospital attached with the U.N Mehta Institute of Cardiology and Research Centre and a Mobile Application for tele-cardiology at the Ahmedabad Civil Hospital in Ahmedabad.
- The U.N Mehta Institute is undergoing expansion to become India's biggest hospital for cardiology equipped with world class medical infrastructure and facilities.

## **Girnar Ropeway:**

- PM Modi inaugurated a Ropeway at Girnar for peoples visiting temples at Girnar Mountain.
- The move will scale up tourism creating local employment opportunities and supporting livelihood.
- Through the ropeway, a distance of 2.3 kms will now be covered in just 7.5 minutes.

- The Governing Body (GB) is the apex executive body of the ILO which decides policies, programmes, agenda, budget and elects the Director-General. At present ILO has 187 members.
- It is composed of 56 titular members (28 Governments, 14 Employers and 14 Workers) and 66 deputy members (28 Governments, 19 Employers and 19 Workers).
- Ten of the titular government seats are permanently held by States of chief industrial importance (Brazil, China, France, Germany, India, Italy, Japan, the Russian Federation, the United Kingdom and the United States).
- The other Government members are elected by the Conference every three years (the last elections were held in June 2014). The Employer and Worker members are elected in their individual capacity.

**India & ILO:**

- India is a founder member of the International Labour Organization, which came into existence in 1919.
- India has ratified 47 ILO conventions and 1 protocol.
- At present the ILO has 186 Members.
- ILO has three organs -International Labour Conferences(General Assembly of the ILO), Governing Body(Executive Council of ILO) and International Labour Office(A permanent secretariat)

- The first sapling of heeng has been planted in Himachal Pradesh's Kwaring village in Lahaul valley.
- Asafoetida, or heeng, is a high value spice crop in India commonly used in Indian Kitchens. It is not cultivated in India.
- India imports about 1,200 tonnes of raw heeng worth Rs 600 crore from Iran, Afghanistan and Uzbekistan.
- **About Heeng:**
- Ferula asafoetida is a herbaceous plant of the umbelliferae family.
- It is a perennial plant whose oleo gum resin is extracted from its thick roots and rhizome. The plant stores most of its nutrients inside its deep fleshy roots.
- The plant takes about five years to produce the extractable oleo gum resin.
- Asafoetida is endemic to Iran and Afghanistan, the main global suppliers.
- **Conditions essential for Heeng cultivation:**
- Heeng thrives best in dry and cold desert conditions.
- The plant can withstand a maximum temperature between 35 and 40 degree, whereas during winters, it can survive in temperatures up to minus 4 degree.
- Regions with sandy soil, very little moisture and annual rainfall of not more than 200mm are considered conducive for heeng cultivation in India.
- During extreme weather, the plant can get dormant.
- Future of Heeng cultivation in India:
- By the end of this year, the target is to cover one hectare with heeng cultivation.
- In the next five years the cultivation is to be extended to 300 hectares.

- Any Cooperative Society with suitable provision in its byelaws to undertake healthcare related activities would be able to access the NCDC fund.
- NCDC assistance will flow either through the State Governments/ UT Administrations or directly to the eligible cooperatives.
- The scheme also provides working capital and margin money to meet operational requirements.
- The scheme provides interest subvention of one percent to women majority cooperatives.
- **About NCDC:**
- NCDC was set up under an Act of Parliament in 1963 for promotion and development of cooperatives.
- Since 1963, it has extended around Rs.1.60 lakh crore as loans to cooperatives.

- On 11 October 2020; India has joined the Five Eyes in asking big tech companies to come up with a solution for law enforcement to access end-to-end encrypted communications.
- Five Eyes is an intelligence alliance comprising Australia, Canada, New Zealand, the United Kingdom and the United States.
- These countries are parties to the multilateral UKUSA Agreement, a treaty for joint cooperation in signals intelligence.
- It has now become the campaign of seven countries as India and Japan also joined the campaign against messages being sent in code language on social media.
- The seven governments demanded backdoors into end-to-end encrypted chats as end-to-end encryption prevents authorities from looking into serious crimes and matters like national security.
- The Five Eyes have made similar calls to tech giants in 2018 and 2019.
- The representatives from the seven governments asserted the need for encryption backdoors.
- These should not just for encrypted instant messaging applications, but also for device encryption, custom encrypted applications and encryption across integrated platforms.
- The statement noted that tech companies themselves cannot identify and respond to violations of their terms of service.
- These include responses to illegal content and activity on its platform, including child sexual exploitation and abuse, violent crime, terrorist propaganda, and attack planning.
- It further noted that end to end encryption makes it difficult for law enforcement agencies “to access content in limited circumstances where necessary and proportionate to investigate serious crimes and protect national security.”
- Seven governments in a press release appealed technology companies to work with governments.
- **They have also instructed to take the following steps, focused on reasonable, technically feasible solutions-**
  - i. Embed the safety of the public in system designs, thereby enabling companies to act against illegal content and activity effectively with no reduction to safety, and facilitating the investigation and prosecution of offences and safeguarding the vulnerable.
  - ii. Enable law enforcement access to content in a readable and usable format where an authorisation is lawfully issued, is necessary and proportionate, and is subject to strong

safeguards and oversight.

iii. Engage in consultation with governments and other stakeholders to facilitate legal access in a way that is substantive and genuinely influences design decisions.

- A total of 22 states and 3 Union Territories participated in the exercise, including four states from North East India.
- To establish uniformity and ensure standardization in the ranking process, States and UTs were divided into Category-X and Category-Y.
- Category-X entails states and UTs with a well-established startup ecosystem.
- Category-Y includes all UTs, except Delhi, and all states in North East India, except Assam.
- The States and UTs were classified as: Best Performers, Top Performers, Leaders, Aspiring Leaders and Emerging Startup Ecosystems.
- Gujarat was the Best performer in Category X followed by Karnataka and Kerala. Uttar Pradesh and Tamil Nadu occupied the lowest positions.
- Andaman and Nicobar Islands was the Best performer in Category Y. Sikkim secured the bottom place.

- “We advise that Syndicate Bank has been excluded from the Second Schedule to the RBI Act, 1934 with effect from April 01, 2020 since it has ceased to carry on banking business with effect from April 01, 2020 vide Notification of March 27 which is published in the Gazette of India...dated September 26 October 02, 2020,” RBI said in a notification on Wednesday(30 September 2020).
- It has issued similar notifications regarding the other five state-owned banks.
- A bank mentioned in the Second Schedule of the Reserve Bank of India Act is known as ‘Scheduled Commercial Bank’.

- These six banks merged with other public sector banks (PSBs) with effect from April 1.
- OBC and United Bank of India merged into Punjab National Bank; Syndicate Bank into Canara Bank; Andhra Bank and Corporation Bank into Union Bank of India; and Allahabad Bank into Indian Bank.
- After the consolidation, there are now seven large PSBs, and five smaller ones.
- There were as many as 27 PSBs in 2017. The total number of PSBs in the country has now come down to 12

## India's External Debt as at the end of June 2020

**The major developments relating to India's external debt as at end-June 2020 are presented below :-**

**Highlights**

- At end-June 2020, India's external debt was placed at US\$ 554.5 billion, recording a decrease of US\$ 3.9 billion over its level at end-March 2020 .
- The external debt to GDP ratio increased to 21.8 per cent at end-June 2020 from 20.6 per cent at end-March 2020.
- Valuation loss due to the depreciation of the US dollar vis-à-vis major currencies such as euro, yen and SDR2 were placed at US\$ 0.7 billion. Excluding the valuation effect, the decrease in external debt would have been US\$ 4.5 billion instead of US\$ 3.9 billion at end-June 2020 over end-March 2020.
- Commercial borrowings remained the largest component of external debt, with a share of 38.1 per cent, followed by non-resident deposits (23.9 per cent) and short-term trade credit (18.2 per cent).
- At end-June 2020, long-term debt (with original maturity of above one year) was placed at US\$ 449.5 billion, recording a decrease of US\$ 2.0 billion over its level at end-March 2020.
- The share of short-term debt (with original maturity of up to one year) in total external debt declined to 18.9 per cent at end-June 2020 from 19.1 per cent at end-March 2020; the ratio of short-term debt (original maturity) to foreign exchange reserves declined to 20.8 per cent at end-June 2020 (22.4 per cent at end-March 2020).

- Short-term debt on residual maturity basis (i.e., debt obligations that include long-term debt by original maturity falling due over the next twelve months and short-term debt by original maturity) constituted 44.0 per cent of total external debt at end-June 2020 (42.4 per cent at end-March 2020) and stood at 48.2 per cent of foreign exchange reserves (49.6 per cent at end-March 2020).
- US dollar denominated debt remained the largest component of India's external debt, with a share of 53.9 per cent at end-June 2020, followed by the Indian rupee (31.6 per cent), yen (5.7 per cent), SDR (4.5 per cent) and the euro (3.5 per cent).
- The borrower-wise classification shows that the outstanding debt of both government and non-government sectors decreased at end-June 2020.
- The share of outstanding debt of non-financial corporations in total external debt was the highest at 42.3 per cent, followed by deposit-taking corporations (except the central bank) (28.1 per cent), general government (18.0 per cent) and other financial corporations (7.4 per cent).
- The instrument-wise classification shows that the loans were the largest component of external debt, with a share of 35.4 per cent, followed by currency and deposits (24.3 per cent), trade credit and advances (18.8 per cent) and debt securities (16.3 per cent)
- Debt service (principal repayments plus interest payments) increased to 8.1 per cent of current receipts at end-June 2020 as compared with 6.5 per cent at end-March 2020, reflecting lower current receipts.

- The capital conservation buffer (CCB) is designed to ensure that banks build up capital buffers during normal times which can be drawn down as losses are incurred during a stressed period.

As per the guidelines, banks in India were required to maintain NSFR(Net Stable Funding Ratio) of 100% from 1 April 2020. The RBI has now deferred it for a second time to 1 April 2021.

#### Capital Adequacy Ratio

Capital Adequacy Ratio (CAR) is the ratio of a bank's capital in relation to its risk-weighted assets and current liabilities.

It is decided by central banks and bank regulators to prevent commercial banks from taking excess leverage and becoming insolvent in the process.

The formula used to measure Capital Adequacy Ratio is =  $(\text{Tier I} + \text{Tier II} + \text{Tier III} \text{ (Capital funds)}) / \text{Risk weighted assets}$

### New species, under the genus Echinops Discovered

**Related Facts:-**

- Recently researchers have discovered a new species of flowering plant from India, named as Echinops sahyadricus.
- This new flowering plant is also known by the English name Sahyadri globe thistle has been obtained from the Rajgad Fort area, Pune Maharashtra.
- It should be noted that this region is located in the Sahyadri hills in the northern Western Ghats of Maharashtra.
- Researchers from India and Italy have achieved success with their collaborative effort.
- The newly discovered species, under the genus Echinops (spiny thistle) and an erect branched flowering herb with stout stems.
- It is endemic to western Maharashtra and found only on a few open hilltops in the northern Western Ghats.
- Information regarding this new species was published on 23 October 2020 in Nordic Journal of Botany.

- The credit to the discovery of Echinops Sahyadricus goes to the Mumbai-based botanist Sushant More from Sathaye College, Vile Parle, Mumbai, and Fabio Conti from the University of Camerino, Italy.
- Harshal Bhosale from the Bombay Natural History Society (BNHS), Mumbai, has also given his valuable contribution in the discovery of this plant.
- The new species grows mostly on open mountain slopes from 800 to 1400 metres (m) above sea level in the northern Western Ghats.
- It is distributed from Salher in Nashik District, which is located in the north and south of Kolhapur district.
- It grows during monsoon – between June and September — and flowers bloom in November. The fruiting occurs in December.
- Researchers said the new species was unique due to the size of its composite inflorescence because a large number of small flowers clustered together.
- They measure up to 9 centimetres (cm) in diameter, which is relatively large compared to other Echinops species around the world.
- Researchers emphasised for the conservation of these plants as infrastructure projects such as road widening and construction activities along these forts could affect the population of the species,
- According to the botanists, this discovery highlights the hidden treasures of the Western Ghats in Maharashtra.
- There are about 130 species of Echinops in the world, out of which five species are found in the country and two in Maharashtra alone.

- The Department of Science and Technology (DST) said, as the infrastructure planned in NSM phase I has already been installed and much of Phase II is in place, the speed of supercomputers in the country will soon reach to around 16 PF.
- According to the Phase III, to be initiated in January 2021, (it) will take the computing speed to around 45 petaflops.
- Department of Science and Technology (DST) explained following facts about NSM-
- The NSM is jointly steered by the Ministry of Electronics and IT (MeitY) and Department of Science and Technology (DST).
- The Mission is being implemented by the Centre for Development of Advanced Computing (C-DAC), Pune and the Indian Institute of Science (IISc), Bengaluru.
- Param Shivay, the first supercomputer assembled indigenously, was installed in IIT (BHU).
- It then followed two more supercomputers by Param Shakti and Param Brahma at IIT-Kharagpur and IISER, Pune, respectively.

- Thereafter, supercomputing facilities were set up in two more institutions, and one is being set up under Phase I, ramping up high power computing speed to 6.6 PF.
- In Phase II, eight more institutions will be equipped with supercomputing facilities by April 2021, with a total of 10 PF compute capacity.

- The genus Abortelphusa is named after the Abor Hills, while the species Namdaphaensis is named after Namdapha.

- In local Singphoo language Nam means water or river and Dapha is the name of a clan of Singphoo tribe.
- Namdapha Reserve
- Namdapha Reserve is for its rich biodiversity, and believed to be the rare area that harbours four large cats: tigers, snow leopards, clouded leopards and leopards.
- This is the eastern most tiger reserve in India with its borders shared with Myanmar. This park is named after Namdapha river flowing through it.
- The species, a small freshwater crab species, is a tribute to Namdapha, the largest protected area in the Eastern Himalayan Biodiversity Hotspot and the Abor Hills.
- Of the 125 freshwater crabs in India, the north-east accounts for 37. Arunachal Pradesh has 15 and Assam has 21.
- The discovery highlights the potential of Arunachal Pradesh as one of the richest biodiversity hotspots in the country.

- *Lepidagathis Ananthapuramensis* is the name given to this perennial woody herb since this rare plant was spotted in the neighborhoods of the Ananthapura lake temple.
- Ananthapura lake temple is the famed temple dedicated to Ananthapadmanabha of Kerala
- An article on the discovery has been published in the latest edition of *Phytotaxa*, a journal on plant taxonomy.
- The plant was spotted during field explorations in the region.
- With its discovery, the number of species of the genus *Lepidagathis* (family *Acanthaceae*) found in India has risen to 34.
- Plants of this species are locally called 'Paramullu'.
- To date, eight species of the genus *Lepidagathis* and three varieties have been reported from Kerala, of which four are endemic to the Western Ghats.
- *Lepidagathis Ananthapuramensis* is closely related to *Lepidagathis keralensis* reported from Madayippura in Kannur district.
- Detailed studies have established the former as a hitherto undescribed species with following characteristics-
- It is an erect woody herb that grows to a height of 50-100 cm.
- It is characterized by a hairy and branched stem, thick and woody rootstock, and hairy leaf veins.
- Its flowers clustered on one side of the inflorescence.

## India Successfully test-fired Anti-radiation Missile

**Question: Recently India successfully test-fired Anti-radiation missile, named as-**

- On 09 October 2020; India successfully test-fired Rudram-1, the tactical anti-radiation missile.
- This missile has been built by India to take down enemy radars and surveillance systems.
- The Defence Research and Development Organisation developed this new generation weapon.
- It was tested at the interim test range Balasore, off the coast of Odisha in the Bay of Bengal.
- The New Generation Anti-Radiation Missile (NGARM), integrated on Su-30MKI fighter aircraft and fired to test its all parameters.
- The IAF will now have the capability to perform SEAD (Suppression of Enemy Air Defence) operations deep into enemy territory.
- This would allow the IAF's strike aircraft to carry out their mission unhindered effectively.
- This test demonstrates the capability of an Anti-Radiation Missile with large stand-off ranges.
- Its range depends on the height at which the fighter jet is flying.
- It can be launched from a height ranging from 500 metres to 15 km and can hit radiation emitting targets within a range of 250 km.
- All radars and Electro Optical Tracking System tracked the launch and point of impact
- The tactical, air-to-surface anti-radiation missile is equipped with a passive homing head that tracks sources of radiation of a wide range of frequencies.
- It can lock into a target not only before launch but also after it has been launched.
- The missile is comparable to the tactical air-to-surface missile AGM-88E Advanced Anti-Radiation Guided Missile that was inducted by the US Navy only in 2017.
- It can engage and relocate integrated air Defence targets and other targets even if equipped with shutdown capability.
- This means even if the enemy shuts down the radar after the missile Rudram is launched, it will still hit the target.

- A team of astronomers at the University of Hawai'i at Mānoa Institute for Astronomy (IfA) has produced the world's largest three-dimensional astronomical imaging catalog of stars, galaxies and quasars.
- The team used data from UH's Panoramic Survey Telescope and Rapid Response System or Pan-STARRS1 (PS1) on Haleakalā.
- The PS1 3 $\pi$  survey is the world's largest deep multi-color optical survey, spanning three-quarters of the sky.
- If A astronomers applied novel computational tools to the catalog, to decipher which of the 3 billion objects are stars, galaxies or quasars.
- It should be known that a quasar is an astronomical object of very high luminosity found in the centres of some galaxies.
- Quasars are powered by gas spiraling at high velocity into an extremely large black hole at the center of a galaxy.
- For the galaxies, the software also derived estimates of their distances.
- The resulting 3-D catalog is now available as a high-level science product through the Mikulski Archive for Space Telescopes.
- It is approximately 300 GB in size, and science users can query the catalog through the MAST CasJobs SQL interface, or download the entire collection as a computer-readable table.
- Astronomers took publicly available spectroscopic measurements that provide definitive object classifications and distances.
- They fed them to an Artificial Intelligence (AI) algorithm as the AI process was key to figure out and accurately determine the same properties from various measures of the colors and sizes of the objects.

- Results of this study were published in Scientific Reports, the open-access mega-journal of the Nature Publishing Group.

- It is important to note that the discovery of Aenigmachannidae came just a year after the discovery of the enigmatic fish, Gollum Snakehead.
- Interestingly both these species were discovered from the same rice fields of northern Kerala.
- Scientists have now conducted detailed studies on its skeleton and genetic assembly of Aenigmachannidae.
- The study led to the recognition that this species, and its congener Aenigmachanna mahabali, represents a new family different from Channidae, in which both species were initially placed.
- These suggest that members of Aenigmachannidae are “living fossils” and comprise an ancient gondwanan lineage.
- It survived during the break-up of the supercontinent (Gondwana) and the northward drift of the Indian subcontinent, about 100 million years ago.

- The name BrahMos is a portmanteau formed from the names of two rivers, the Brahmaputra of India and the Moskva of Russia.

- These are Yudh Abhyas (February 2021) and Vajra Prahar (March 2021).

### **India –US military relations : Chronology**

- The first of the four agreements, the General Security Of Military Information Agreement (GSOMIA), was signed by India and the U.S. in 2002.
- The second agreement, the Logistics Exchange Memorandum of Agreement (LEMOA), was signed by the two countries on 29 August 2016.
- The LEMOA permits the military of either country to use the others' bases for re-supplying or carrying out repairs.
- The third agreement, Communications Compatibility and Security Agreement (COMCASA) was signed during the inaugural 2+2 dialogue in September 2018.
- The fourth agreement, Basic Exchange and Cooperation Agreement (BECA) has not yet been signed. It permits the exchange of unclassified and controlled unclassified geospatial products, topographical, nautical, and aeronautical data, products and services between India and the US National Geospatial-Intelligence Agency (NGA).
- In June 2015, US defence secretary Ashton Carter visited India and became the first American defence secretary to visit an Indian military command.
- In March 2016, India rejected a proposal by the US to join naval patrols in the South China Sea alongside Japan and Australia.

## **The Suture zone of the Himalayas**

### **Related Facts:**

- Recently it has been observed through a research that The suture zone of the Himalayas or the Indus Suture Zone (ISZ) is tectonically active.
- This is an observation obtained from the detailed mapping of geological features of the region.
- The study in this regard has been conducted by a group of Scientists from Wadia Institute of Himalayan Geology (WIHG), Dehradun.
- It should be noted that WIHG is an autonomous institute under the Department of Science and Technology, Government of India.
- Scientists through their study concluded that the suture zone of Himalaya that was conventionally thought to be locked is tectonically active.
- The suture zone of the Himalayas or the Indus Suture Zone (ISZ) is located in the Ladakh region where Indian and Asian Plates are joined.
- This could have major implications in terms of earthquake study, prediction, understanding the seismic structure of the mountain chains well as its evolution.
- They carried out the mapping of the remote regions of Ladakh that forms the most hinterland part of the Himalaya.
- The study was published recently in the journal Technophysics.

- **The geologists observed following details about this zone-**
- Here sedimentary beds are tilted and thrust broken
- The rivers are associated with uplifted terraces, and the bedrock shows brittle deformation that occurred at much shallower depths.
- **Laboratory Study:-**
- These deformed geological features were then dated in the laboratory at Dehradun using a technique called Optically Stimulated Luminescence (OSL).
- OSL is the method for carrying Luminescence dating of geological sediments
- Scientists then reviewed the data of seismicity and denudation rate.
- The combination of field and lab data suggested the region of the Indus Suture Zone (ISZ) has been neo-tectonically active since the last 78000 — 58000 years.
- Scientists are of the view that recent earthquake in 2010 of low magnitude 4.0 near the village of Upshi that occurred due to a thrust rupture.
- Himalaya were known to be made up of north dipping thrusts like the Main Central Thrust (MCT), the Main Boundary Thrust (MBT), and the Main Frontal Thrust (MFT).
- As per the established models, all of these thrusts except MFT are locked, and overall deformation in Himalaya is being accommodated only along with the MFT.
- The new findings, which suggest a more remote fault at the suture zone being neo-tectonically active, could call for a serious relook into the existing evolutionary models using new techniques and a larger geological database.

- It has been in orbit around the asteroid for nearly two years preparing for the Touch and Go manoeuvre.
- The mission was planned to perform “Touch-And-Go” manoeuvre, which was managed by Lockheed Martin Space in Denver, Colorado USA.
- Most importantly it was a first for the United States, only Japan has previously secured asteroid samples.
- The robotic arm’s collection device, shaped like an oversized shower head, is designed to release pressurised gas to kick up debris.
- Bennu, which is more than 4.5 billion years old, was selected as a target because scientists believe it is a small fragment of what was once a much larger space rock that broke off during a collision between two asteroids early on in the history of the solar system.
- **Scientific reason in studying Asteroids:-**

- Asteroids are like time capsules floating in space that can provide a fossil record of the birth of our solar system.
- Asteroids can provide valuable information about how planets, like our own, came to be.
- **Asteroid Bennu:**
- The NASA team has determined two key discoveries about Bennu-
- First, that between 5 and 10 percent of Bennu's mass is water.
- Second, its surface is littered with carbon-rich molecules.
- Atomic-level analysis of samples from Bennu could help scientists better understand what role asteroids played in bringing water to the Earth and seeding it with the prebiotic material that provided the building blocks for life.
- Studying that material could also help scientists discover whether life exists elsewhere in the solar system, as well.

- Its drawings are 12 to 15 inches thick. This entire figure is about 121 feet long.
- It has been calculated that the cat's shape was drawn in the last days of the Parakas period, which was between 500 BCE and 200 CE.
- Important to note that in November 2019 140 Nazca lines were found in this mysterious desert of Peru which is about 2100 years old.
- Japanese researchers had done research for 15 years with the help of drones and AI.

- A bird, human-shaped animal, two-faced snake and a killer whale fish were also found in these 140 Nazca lines.
- Experts believe that the then Nazca people believed that the gods could see it from the sky.
- These lines are dug on the upper surface of the ground parallel to the lower stone.

- India's Power and New and Renewable Energy Minister(R.K.Singh) welcomed the seventh initiative on heating and cooling to be introduced for discussion in the Third Assembly.
- He is the president of ISA third assembly.
- **Four new Vice-Presidents were also chosen to represent the four regions of ISA. These are as below —**

Fiji & Nauru	Asia Pacific Region
Mauritius & Niger	Africa Region
UK & Netherlands	Europe and others Region
Cuba and Guyana	Latin America and Caribbean Region

### **Initiatives of the ISA Secretariat**

The Assembly also approved the initiatives of the ISA Secretariat in institutionalizing ISA's engagement with the private and public corporate sector through the Coalition for Sustainable Climate Action (CSCA). Ten public sector organisations in India presented a cheque for 1 million USD each at the assembly.

### **Solar Energy**

- Solar Energy has come a long way in last 5 years and is now the fastest growing energy source globally.
- Solar energy is already contributing around 2.8% of global electricity ,and if trends were to continue, by 2030, solar will become most important source of energy for electricity production in large part of the world. Various activities and programmes initiated by ISA since the 2nd Assembly
- Six programmes and two projects are now underway covering various aspects of solar energy. A robust pipeline of more than US\$ 5 Billion has been developed for solar energy applications to meet lighting, irrigation, drinking water and productive energy requirement of the ISA member countries, which have so far been largely deprived of modern energy services.

- ISA has aggregated a demand for more than 270,000 solar pumps across 22 countries, more than 1 GW of Solar Rooftop across 11 countries, and more than 10GW of Solar Mini-grids across 9 countries under its respective programmes. Recently ISA has initiated programmes for segregation of demand for 47 million Home Power Systems which will not only meet subsistence energy needs of the rural households but will also contribute to improving health services and availability of portable water.

### **France's involvement**

- The Co-President of the Assembly Ms Barbara Pompili, France's Minister pointing out that of the 1.5 billion euros of financing France committed for solar projects in ISA member states up until 2022, 1.15 billion € has been committed to concrete projects.
- France has also supported the collaboration with the World Bank to mobilise financing: a facility "Sustainable Renewables Risk Mitigation Initiative" (SRMI) should help mobilize 18 billion € in private investment to finance more than 10 gigawatts of solar projects, and a first project is being launched in Mozambique with the support of France and the European Union.

### **Commitment of the United Kingdom**

According to Mr. Alok Sharma(The President of COP26), The UK planned to phase out coal within the next five years and to bring all greenhouse gas emissions to net zero by 2050.

### **Solar awards**

- For the first time since the inception of the framework agreement of ISA, Solar awards were conferred on countries of the region as well as institutions working for solar. The assembly witnessed the conferment of the Visvesvaraya award which recognizes the countries with maximum floating solar capacity in each of the four regions of ISA.
- The award carries an amount of 12,330 USD as prize money, a scroll and a certificate.
- The awards went to Japan for the Asia Pacific region and the Netherlands for Europe and Others region.

### **Kalpana Chawla awards**

- The Haryana Chief Minister, Shri M. L. Khattar announced the Kalpana Chawla awards named after the American astronaut of Indian origin, to Dr.Bhim Singh from IIT Delhi (India) and Dr.Aaesha Alnuaimi from Dubai Electricity and Water Authority (United Arab Emirates).
- The awards recognise outstanding contribution of scientists and engineers working in the field of solar energy.

### **Diwakar award**

- The Diwakar award instituted by ISA out of the contribution made by India's Minister for Railways and Commerce & Industry, Shri Piyush Goyal of 25,000 USD received

by him from the University of Pennsylvania, has been awarded to Arpan Institute (Haryana) and Arushi Society.

- The award recognizes organisations & institutions that have been working for the benefit of differently-abled people and have maximised the use of solar energy in the host country.

Work with WRI(World Resources Institute) & Vision of One Sun, One World, One Grid

- Third assembly welcomed the move of the ISA to work with WRI to develop a roadmap for mobilization of USD 1 Trillion by 2030.  
The Kingdom of the Netherlands, Bloomberg Philanthropies, Bloomberg New Energy Finance and Climate Works Foundation providing the required financial and technical assistance for preparation of the Roadmap.  
The roadmap will also analyse the potential for mobilising further investments in solar energy going beyond solar power projects to solar energy applications in transportation and cooling and heating and for implementing the vision of One Sun, One World, One Grid.

## The ISA

- The ISA is an initiative that was launched by the Prime Minister of India and the President of France on 30 November 2015 at Paris, France on the side-lines of the COP-21. The overarching objective of the ISA is to collectively address key common challenges to the scaling up of solar energy in ISA member countries.

- In August, Facebook announced a ban on QAon groups.
- Last year, the FBI said fringe political conspiracy theories including QAon are a domestic threat.
- It is anticipated that these movements, likely to motivate some domestic extremists, wholly or in part, to engage in criminal or violent activity.
- **About QAon:-**
- QAon took shape around 2017 when an anonymous user called “Q” or “Q Clearance Patriot” started posting conspiracy theories.

- “Q” refers to a security clearance given by the US Department of Energy for access to top-secret information.
- Q, who claims to be a high-ranking intelligence officer with access to sensitive information of the Trump administration.
- He started posting on the platform 4chan in 2017, and now posts on 8kun, a website run by the founders of 8chan.
- 8chan was shut down after the mass shooting in El Paso, Texas in 2019, the killers had posted hate content on 8chan.
- **The conspiracy theory:-**
- QAnon followers believe that the world is being run by a cabal of paedophiles who worship Satan and that one of Trump’s aims as US President is to unmask the cabal and punish them.
- According to the conspiracy theorists, Trump is secretly preparing for a day of reckoning, “The Storm”, when members of the “deep state” will be executed.
- This theory has been gaining traction among some far-right voters ahead of the November 3 presidential election.
- The conspiracy theorists believe that Democrats such as Hillary Clinton and Barack Obama, and Hollywood actors Tom Hanks and Oprah Winfrey, are part of a global child sex-trafficking ring.
- This takes off from the “Pizzagate” theory, long debunked, which circulated during the 2016 presidential election.
- Far-right activists had claimed that Clinton, who contested against Trump, was running a child trafficking racket from the basement of a pizza parlour in Washington, DC.

- It has been developed in collaboration of the Central Mechanical Engineering Research Institute (CMERI).
- **Highlights of the project:**
- The CSIR-CMERI developed Municipal Solid Waste Processing Facility has helped in achieving Decentralised Decimation of Solid Wastes.
- It has also helped in creating value-added end-products from abundantly available redundant stuffs such as Dry Leaves, Dry Grass etc.
- The primary focus of CSIR-CMERI is to unburden the common households from the segregation responsibilities through Advanced Segregation techniques.
- The Bio-Digestion process adopted has minimum pollution factor.

- The MSW facility has been equipped with special capabilities to deal with a diverse range of waste including Masks, Sanitary Napkins, Diapers etc.
- The MSW facility has been with special disinfection capabilities to help Break the COVID Chain through UV-C Lights and Hot-Air Convection methods.
- It has also been achieved optimum Energy Sufficiency in the MSW facility by adding the solar energy technology, which can also feed the surplus Energy Supply onto a Mini-Grid.
- **Present waste management scenario:**
- It is estimated that about 62 million tonnes of waste are generated annually in the country.
- Only about 75- 80% of the municipal waste gets collected and out of this only 22-28 % is processed and treated and rest is dumped in landfill sites.
- It is projected that by 2031 MSW generation shall increase to 165 million tones.
- **Issues associated with MSW management include-**
- limited utilization of recycling activities,
- inadequate management of non-industrial hazardous waste,
- Inadequate landfill disposal, inadequate service coverage etc.
- Poor MSW results in pollution of surface and groundwater (leakages from landfills), health, environmental and economic threats on nearby population and properties etc.
- Government had notified the new Solid Waste Management Rules (SWM), 2016 which are applicable beyond Municipal areas and extend to urban agglomerations, census towns, notified industrial townships etc.
- Decentralised Waste Management technology developed by CSIR-CMERI can result in drastic reduction of expenditure related to Transportation Logistics and can help reductions in CO2 emissions, by reducing fossil fuel usage.
- The Scientifically Decentralised Waste Processing Hubs will help multiply outreach for various locations and will also boost the manufacturing potential for the residents of the region.
- This CSIR-CMERI MSW Technology envisions a Zero-Landfill and a Zero Waste City in addition to developing Job-Creation opportunities.
- This technology will also help create a revived Green Energy reliant India.

- WFP's Cost of a Plate of Food 2020 report highlights the countries where a simple meal such as rice and beans costs the most, when compared with people's incomes.
- South Sudan is once again top of the list, with basic ingredients costing a staggering 186 percent of a person's daily income.
- Seventeen of the top 20 countries featured in the index are in sub-Saharan Africa.
- Since the onset of the pandemic, the daily income spent on food by someone living in South Sudan has risen 27 points to 186 percent.
- If a resident in New York State had to pay the same proportion of their salary for a basic meal, the meal would cost US\$393.
- Report estimates that the lives and livelihoods of up to 270 million people will be under severe threat in 2020, unless immediate action is taken to tackle the pandemic.
- According to the report people in New York State pay just 0.6% of their income on a plate of food.
- On an average an Indian spends 3.5% of his/ her daily income for a plate of food.
- This is the third edition of WFP's Cost of a Plate of Food report (formerly called Counting the Beans) with 36 countries featured this year.

- On 11 October 2020; Ministry of Environment GoI announced about the Blue Flag Certification, given to eight Indian beaches by an international jury.
- Eight beaches spread across five states and two union territories in India.
- These beaches are Shivrajpur (Dwarka-Gujarat), Ghoghla (Diu), Kasarkod and Padubidri (Karnataka), Kappad (Kerala), Rushikonda (AP), Golden (Puri-Odisha) and Radhanagar (A&N Islands)
- The International jury which awarded this recognition have comprised of members of the UN Environment Programme-UNEP, International Union for Conservation of Nature-IUCN) etc.

- Prime Minister Narendra Modi described the Blue Flag certification for eight beaches as a 'wonderful feat'.
- He said that it showcases the importance India attaches to protecting such spots and furthering sustainable development.
- India is also the first country in Asia-Pacific region which has achieved this feat in just about 2 years' time.
- The environment ministry on this occasion also informed that India has also been awarded the third prize by the jury under the "International Best Practices" for pollution control in coastal regions.
- With the feat, India is now in the league of 50 'Blue Flag' countries.
- According to the government, India is planning to achieve Blue Flag certification for 100 such beaches.

#### **About BLUE FLAG CERTIFICATION:-**

- The Blue Flag certification is a globally recognised eco-label. Blue Flag is accorded by Foundation for Environment Education (FEE), Denmark.
- **Blue Flag certification is granted based on 33 criteria under four heads –**
  - I. Environmental education and information
  - II. Bathing water quality
  - III. Environment management and conservation
  - IV. Safety and services at the beaches.
- The Blue Flag certification is granted to beaches, marinas, or sustainable boating tourism operators that meet FEE's set standards on the environment.
- In order to qualify for the Blue Flag, a series of stringent environmental, educational, safety, and accessibility criteria must be met and maintained.
- India is the only country that has received the Blue Flag certification in 2 years' time.
- Japan, South Korea and UAE are the only other Asian nations that have been conferred with a couple of Blue Flag beaches in a time frame of about 5 to 6 years.

- Global GDP will fall by 4.8% in 2020 before rising by 4.9% in 2021. The trade decline in Asia of 4.5% for exports and 4.4% for imports in 2020 will be smaller than in other regions.
- Downside risks still predominate, particularly if there is resurgence of COVID-19 cases in the coming months.
- The 14.3% quarter-on-quarter decline in world merchandise trade in the second quarter is the largest on record, but high-frequency data point to a partial rebound in the third quarter.

- On 28 September, 2020 The World Health Organisation (WHO) made an announcement that it will provide about 120 million antigen rapid diagnostic tests in the months ahead.
- These tests will be available to low- and middle-income countries (LMIC).
- W.H.O has done milestone agreements for this purpose with the Abbott, SD Biosensor and the Gates Foundation.
- WHO Director General Tedros Adhanom Ghebreyesus has made following announcement regarding new rapid testing kits-
- This will enable the expansion of testing, particularly in hard-to-reach areas that do not have lab facilities or enough trained health workers to carry out PCR tests.
- The tests are priced at a maximum of \$5 per unit, substantially cheaper than PCR tests.
- This also assured that there may be further coming down of testing costs.
- To achieve this purpose Volume guarantee agreements have been signed with rapid diagnostic test producers Abbott and SD Biosensor and the Bill and Melinda Gates Foundation (BMGF).
- WHO has declared that the tests provide reliable results in 15 to 30 minutes, as compared to a few hours or days, and at a lower price.
- This is a vital addition to their testing capacity and is especially important in areas of high transmission.
- It has been explained that the sooner Covid-19 is diagnosed, the quicker action can be taken to treat and isolate those with the virus and trace their contacts.
- Why these test preferred by WHO
- Portability
- The tests developed by Abbott and SD Biosensor are portable, reliable and easy to administer.
- According to the WHO through these kits, testing is possible in near-person, decentralized healthcare settings.
- Rapid Antigen Testing for SARS-CoV-2:-
- Rapid antigen tests are commonly used in the diagnosis of respiratory pathogens, including influenza viruses and respiratory syncytial virus (RSV).
- The US. Food and Drug Administration (FDA) has granted emergency use authorization (EUA) for antigen tests that can identify SARS-CoV-2.
- Antigen tests are immune assays that detect the presence of a specific viral antigen, which implies current viral infection.
- Antigen tests are currently authorized to be performed on nasopharyngeal or nasal swab specimens placed directly into the assay's extraction buffer or reagent.
- The currently authorized antigen tests are not restricted to use on persons of a certain age.
- Antigen tests are relatively inexpensive and can be used at the point-of-care.
- The currently authorized devices return results in approximately 15 minutes.
- Antigen tests for SARS-CoV-2 are generally less sensitive than viral tests.
- Viral tests are highly sensitive and able to detect nucleic acid using reverse transcription polymerase chain reaction (RT-PCR).
