- The rank of India has decreased by two places to 142nd from 140th position with a score of 45.33 in the "The World Press Freedom Index 2020" which has analysed 180 countries.
- This decline in rank is showing an improvement in the security of Indian media as in 2019 there was no murders of journalists were recorded as against six in 2018.
- However, constant press freedom violations still remain, including police violence against journalists, ambushes by political activists, and reprisals instigated by criminal groups or corrupt local officials.

## Important facts:

- India drops two places on global press freedom index 2020
- The World Press Freedom Index is compiled by Paris-based Reporters Sans Frontieres (RSF), or Reporters Without Borders.
- The index has been topped by Norway with a score of 7.84 while North Korea stood at last rank of 180 with a score of 85.82.
- Since 2002 it is published annually by RSF to rank 180 countries according to the level of freedom available to journalists.

# The Epidemic Diseases (Amendment) Ordinance, 2020

Related facts:

- The Central government has today promulgated an Ordinance to amend the Epidemic Diseases Act, 1897 to make attacks on doctors and healthcare workers a cognizable and non-bailable offence.
- The Ordinance is called 'The Epidemic Diseases (Amendment) Ordinance, 2020'
- The Union Cabinet had approved the ordinance on April 22.
- The ordinance seeks to end violence against health workers amid several reports of attacks on medics. It seeks to make such acts of violence as non-bailable offences, increase maximum penalty to 7 years of jail term and provide compensation for the damage caused to property.
- The ordinance defines violence as harassment and physical injury to the medical personnel and damage to property.
- The Ministry of Home Affairs has issued directions to all the states to ensure adequate security to the medical staff, healthcare professionals and other frontline workers to end violence against them.
- The IMA had proposed to hold 'White alert' and 'Black day' protests on April 22 and 23.
- The protests have now been called off.

## **New Amendments to Epidemic Act 1897**

- The new amendments include heavy fines for any kind of violence against health workers and imprisonment up to 7 years. The offence has also been made a nonbailable offence.
- In the case of grievous injuries to the healthcare workers, the accused can face imprisonment ranging from 6 months to 7 years. They can also be penalised with a fine ranging from Rs 1-5 Lakhs.
- Such crimes have also been made cognizable and non-bailable. The investigation in such cases will be done within 30 days.
- Those found guilty will be sentenced to a jail term ranging from 3 months to 5 years and will face fine worth Rs 50000 to Rs 2 lakh.
- Besides this, the amendments include provisions to provide compensation for the injury caused to the healthcare service personnel or for causing any kind of damage or loss to

the property. For the damage caused to the vehicles or clinics of the medics, the accused will be required to pay a compensation amount, which will be twice the market value of the damaged property.

On April 10, 2020, A meeting of the Empowered Groups of Officers under the Chairmanship
of Principal Secretary to Prime Minister reviewed the efforts of eleven empowered groups
formed to tackle the challenges posed by the spread of COVID-19.

## Issues:

- The issues related to supply chain and logistics management for availability of necessary items was discussed at large in this meeting.
- PMO also ensured that efforts undertaken for the benefit of stakeholders are duly delivered.

- The officials directed that all necessary steps to assist farmers harvest their produce while maintaining social distancing should be ensured by the states.
- Emphasis was also laid on confidence building measures and percolation of guidelines of the Ministry of Home Affairs at the ground level.
- The gathering reviewed and expressed satisfaction at the detailed testing protocol and procedure, under which around one lakh fifty thousand samples have been tested till date.
- It was also informed that Centre is in constant touch with States and District level monitoring
  is being undertaken to arrange for shelter for the vulnerable groups like migrants and
  homeless.
- The officials also took note of the ramped up production of PPEs and capacity building for healthcare personnel.
- Principal Secretary suggested that coordination with NGOs at district level to be done to avoid overlaps and proper utilization of resources.
- The officials also took stock of the progress of the welfare measures through the economic relief package under PM GaribKalyanYojana.
- Steps taken to ensure timely information dissemination throughout the country were discussed and ensuring last mile outreach through communication in regional languages was emphasized.
- The officials also emphatically called for enhanced user engagement with AarogyaSetu app.
   The meeting was attended by senior officials of Prime Minister's Office and other Ministries under the Government of India.

- Situation is specially serious in Indore (MP), Mumbai and Pune (Maharashtra), Jaipur (Rajasthan) and Kolkata, Howrah, Medinipur East, 24 Parganas North, Darjeeling, Kalimpong and Jalpaiguri in West Bengal.
- IMCTs to focus on complaints of implementation of lockdown measures as per guidelines, supply of essential commodities, social distancing, preparedness of health infrastructure, etc..
- The Committees have been constituted by the Central Government in exercise of the powers, conferred, inter alia, under Section 35(1), 35(2)(a), 35(2)(e) and 35(2)(i) of the Disaster Management Act 2005.
- IMCTs will commence their visits at the earliest.

- The Act legally entitles upto 75% of the rural population and 50% of the urban population to receive subsidized foodgrains under Targeted Public Distribution System.
- About two thirds of the population therefore is covered under the Act to receive highly subsidized foodgrains.
- The National Food Security Act, (NFSA) 2013 is being implemented in all the States/UTs, on an all India basis.
- Out of maximum coverage of 81.35 crore, around 80 crore persons have been covered under NFSA at present for receiving highly subsidized foodgrains.
- The identification of beneficiaries by States/UTs is a continuous process, which involves exclusion of ineligible/fake/duplicate ration cards and also exclusion on account of death, migration etc. and inclusion on account of birth as also that of genuine left-out households.

- Sir H.N. Reliance Foundation Hospital has also offered to set up special medical facilities to quarantine travellers from notified countries and suspected cases identified through contact tracing.
- Reliance Life Sciences is importing additional test kits and consumables for effective testing.
- RIL has also built a fully-equipped isolation facility in Lodhivali, Maharashtra and handed it
  over to the district authorities.
- This first-of-its-kind-in-India centre is fully funded by Reliance Foundation and includes a negative pressure room that helps in preventing cross contamination and helps control infection.
- The Negative Pressure Room is a technique in medical centres that prevent crosscontamination. This allows air to flow into the room and prevents air from escaping out of the
- In this technique, air is allowed to flow inside the room through a small gap under the door.
   The air in some cases is filtered using UV radiation or chemical means before being sent out.
- Smoke test is used to determine negative pressure. A tube with smoke is held at the bottom
  of the negative pressure room door. The direction of travel of the smoke helps to determine
  the working of the system. If the smoke travels outwards, the room is not in negative
  pressure.

- Over 3000 persons have attended the gathering held on 13-15 March 2020.
- The congregation caused an easy transmission of coronavirus from affected to normal person.
- Later, the new carriers of Covid 19 came in contact with more peoples which led to the huge rise in positive cases countrywide.
- As of Health Ministry, around 30-35 percent of the Covid 19 cases countrywide belongs to the Tablighi Jamat.

## Tablighi Jamat: What and Why?

- In the phrase Tablighi Jamat, the word Tablighi means preachers and Jamat means group. So, collectively the word Tablighi Jamat means the group of preachers.
- It is an Islamic missionary movement that focuses on urging Muslims to return to practising their religion as it was practised during the lifetime of the Islamic prophet Muhammad, and particularly in matters of ritual, dress and personal behaviour.
- It was established in 1927 by Muhammad Ilyas al-Kandhlawi in Mewat region of India.
- The organisation is estimated to have between 150 million to 250 million adherents (the majority living in South Asia), and a presence in somewhere between 180 and 200 countries.
- The Jamat, an apolitical organisation, believes in the message of 'DeenkiMehnat' which means strengthening the Islamic way of life.
- The organisation's activities are coordinated through centres and headquarters called Markaz.
- TablighiJamaat is maintained from its international headquarters, called NizamuddinMarkaz, in the Nizamuddin West district of South Delhi, India, from where it originally started.
- It also has country headquarters in over 200 countries to co-ordinate its activities.
- These headquarters organise volunteer, self-funding people in groups, averaging ten to twelve people, for reminding Muslims to remain steadfast on path of Allah.
- These jamaats and preaching missions are self funded by their respective members.

## **Chronology of Nizamuddinmarkaz Event:**

 March 12: Delhi Govt prohibits gatherings of more than 200 people amid the Coronavirus outbreak.

- March 13: 3400 people gather at the Nizamuddinmarkaz as part of a religious gathering.
- March 16: Delhi CM ArvindKejriwal announces that no religious, social, political gatherings of more than 50 people are allowed in Delhi till March 31.People at the NizamuddinMarkaz still continue to stay.
- March 20: 10 Indonesians who attended the gathering in Delhi test positive in Telangana.
- March 22: Prime Minister Narendra Modi's Janta Curfew is observed across nation. No public gatherings were allowed for a day.
- March 23: 1500 people vacates the Markaz.
- March 24: PM Modi announces nationwide lockdown for 21 days. No public gatherings, any kind of non-essential movement outside residences allowed. Only essential services allowed to remain functional.
- March 24: Nizamuddin Police asks remaining people at the Markaz to vacate the area.
- March 25: Around 1000 people are still residing in the area defying lockdown orders. A
  medical team visits the Markaz and suspected cases are isolated in a hall within the
  building. Jamaat officials go to the SDM's office. File an application for permission to vacate.
  Vehicles list was also given to seek passes.
- March 26: An Indian preacher who attended the gathering in Delhi is tested positive and dies in Srinagar.
- March 26: SDM visits the Markaz and calls the Jamaat officials for a meeting with the District Magistrate.
- March 27: Six coronavirus suspects are taken away from the Markaz for medical checkup and are later put in a quarantine facility in Jhajjar, Haryana.
- March 28: A World Health Organisation (WHO) team along with the SDM visit the Markaz.
   33 people who were taken for medical checkup are isolated at Rajiv Gandhi Cancer Hospital in Delhi.
- March 28: ACP, Lajpat Nagar, sends a notice to the Markaz to vacate immediately.
- March 29: Markaz officials respond to the ACP's letter saying no new people were allowed to gather post the nationwide lockdown announcement. The current gathering had started much before the lockdown and that the PM in his lockdown speech said jojahaanhai, vahinrahe (stay put wherever you are).
- 29 March night: Police and health authorities start taking out people from the Markaz and send them to hospitals and quarantine facilities.

- The Treaty provides a legal framework for seeking extradition of terrorists, economic offenders, and other criminals from and to Belgium.
- An offence punishable under the laws of both the countries with imprisonment for one year and more is called an extraditable offence.
- Offences relating to taxation, or revenue or is one of a fiscal character also fall within the scope of this Treaty.
- Extradition is the formal process of one state surrendering an individual to another state for prosecution or punishment for crimes committed in the requesting country's jurisdiction.
- This is generally enabled through a bilateral or multilateral treaty.
- The legal basis for extradition with countries with whom India does not have an Extradition treaty is provided by Section 3 (4) of the Indian Extradition Act, 1962.

## **Salient Features of the Treaty:**

- Obligation to Extradite: Each Party agrees to extradite to the other any person found in its territory, who is accused or convicted of an extraditable offence in the territory of the other Party.
- However, extradition of nationals is discretionary. The nationality will be determined at the time the offence was committed.
- Mandatory Grounds for Refusal Under the Treaty: The offence involved is a political offence.
- The offence is a military offence.
- The request for prosecution has been made on account of his race, sex, religion, nationality or political opinion.

- The earthquake, 218 km south-southeast of the town of Severo, struck at a depth of 56.7 km (35 miles) as per the U.S. Geological Survey (USGS).
- The Pacific Tsunami Warning Centre (PTWC) said that hazardous tsunami waves were possible within 1,000 km of the earthquake's epicentre.
- However, later it said, "only very small tsunami waves were generated by this earthquake and there is no further threat".
- The Pacific Tsunami Warning Centre has warned hazardous Tsunami waves on the coasts of the Kuril Islands. However, the waves are to be less than 30 centimetres in high.
- The U.S. National Oceanic and Atmospheric Administration said a tsunami watch was issued for the state of Hawaii.
- There were no immediate reports of damage or casualties.
- Kuril Islands are stretched from the Japanese island of Hokkaido to the southern tip of Russia's Kamchatka Peninsula separating Okhotsk Sea from the North Pacific Ocean.
- It consists of 56 islands and minor rocks.
- The chain is part of the belt of geologic instability circling the Pacific and contains at least 100 volcanoes, of which 35 are still active, and many hot springs.
- Earthquakes and tidal waves are common phenomena over these islands.
- The Kuril Islands are a volcanic Archipelago that separates Sea of Okhotsk from the Pacific Ocean. The islands are currently under Russian Administration. However, claims of Japan over 4 southern most islands of the Archipelago have led to the ongoing Kuril Islands Dispute.
- The Islands are located at the tectonically instable region called the "Ring of Fire".
- The Ring of Fire is the areas of Pacific Ocean where several volcanic eruptions and earthquakes occur. There are more than 452 volcanos in the region. This accounts to 75% of world's volcanos. Also, 91% of world earthquakes occur in the region.

- This was a measure towards social safety for MFP gatherers, who are primarily members of the Scheduled Tribes (STs) most of them in Left Wing Extremism (LWE) areas.
- Ensure that the tribal population gets a remunerative price for the produce they collect from the forest and provide alternative employment avenues to them.
- Establish a system to ensure fair monetary returns for forest dweller's efforts in collection, primary processing, storage, packaging, transportation etc, while ensuring sustainability of the resource base.
- Get them a share of revenue from the sales proceeds with costs deducted.

## **Minor Forest Produce (MFP):**

The Minor Forest Produce (MFP), also known as Non-Timber Forest Produce (NTFP), is a
major source of livelihood and provides essential food, nutrition, medicinal needs and cash
income to a large number of STs who live in and around forests. An estimated 100 million
forest dwellers depend on the Minor Forest Produce for food, shelter, medicines, cash
income, etc.

## Finance Bill passed in Lok Sabha

• On March 23, 2020, Finance Minister Nirmala Sitaraman introduced the Finance Bill, 2020. The bill was introduced and passed in Lok Sabha without any discussion.

- The bill was hurriedly passed in the Lok Sabha without the customary discussion or reply by the Union finance minister and duly returned by the Rajya Sabha as the country headed for a lockdown to fight the coronavirus crisis.
- The amendments moved by finance minister Nirmala Sitharaman covered the taxation of petrol and diesel, definition of tax residence and clarifications related to dividend distribution tax (DDT).

## **Key changes:**

- The government raises special additional excise duty, by up to Rs 18 a litre on petrol, up from Rs 10 now and up to Rs 12 a litre on diesel, up from Rs 4 now.
- The intention to raise the taxes on auto fuel comes at a time when the government is looking for resources to announce a financial package to fight the impact of the coronavirus crisis.
- In direct taxes, a key amendment that Finance minister introduced is to relax the provision relating to tax residence.
- The original Finance Bill had proposed to reduce the time Indian citizens or persons of Indian origin needed to spend in India to qualify as Indian tax resident, from 182 days to 120 days in the previous year. "The amended Bill now provides that the lower 120 day rule will not apply if the Indian-sourced income of such persons is less than Rs 15 lakh in the relevant financial year,".
- The tax deducted at source (TDS) rate on payment of dividend to non-resident and foreign company has been set at 20%.
- The proposal for taxing dividends in the hands of shareholders by abolishing the dividend distribution tax (DDT) was also passed. While the new rule kicks into effect from April 1, 2020, the government has clarified that shareholders will have no tax liability if the company issuing the dividend has paid the DDT before April 1.
- Equalisation levy of 2% on non- resident e- commerce unless they have a PE in India.
- Tax exemption to Sovereign wealth fund extended to pension funds for infra investment.
- No 2% on withdrawal of over Rs 1 crore cash from banks,co- operative banks,PO.
- Tax on cash withdrawal of over Rs 20 lakh at the rate of 2%, if tax return not filed for 3 years with effect from July 1 2020.
- Tax on cash withdrawal of over Rs 1 crore at 5 percent, if tax return not filed for 3 years with effect from July 1 2020.

## **Understanding the Concept:**

- A Finance Bill, as the name suggests, concerns the country's finances it could be about taxes, government expenditures, government borrowings, revenues, etc. Since the Union Budget deals with these things, it is passed as a Finance Bill.
- The Constitution defines financial legislation into two categories: Money Bills and Financial Bills
- Money Bills –Article 110
- Financial Bills (I)— Article 117 (1)
- Financial Bills (II)— Article 117 (3)
- All Money bills are Financial bills but all Financial bills are not Money bills.
- Only those financial bills are Money bills which contain exclusively those matters which are mentioned in Article 110 of the Constitution.
- Money bills are certified by the Speaker of Lok Sabha.

## Financial Bills (I):

- A financial bill (I) contains not only any or all the matters mentioned in the Money Bill, but also other matters of general legislation. It is dealt under Article 117 (1) of the Constitution.
- It is similar to a money bill in two respects-
- Both of them can be introduced only in the Lok Sabha and not in the Rajya Sabha.

- Both of them can be introduced only on the recommendation of the President.
- In all other respects, a financial bill (I) is treated as an ordinary bill. ie.
- it can be either rejected or amended by the Rajya Sabha.
- In case of a disagreement between the two Houses over such a bill, the President can summon a joint sitting of the two Houses to resolve the deadlock.
- When the bill is presented to the President, he can either give his assent to the bill or withhold his assent to the bill or return the bill for reconsideration of the Houses.

## Financial Bills (II):

- A financial bill (II) contains provisions involving expenditure from the Consolidated Fund of India, but does not include any of the matters mentioned in Article 110. It is dealt under Article 117 (3) of the Constitution.
- It is governed by the same legislative procedure which is applicable to an ordinary bill.
- Such Bills can be introduced in either House of Parliament. However, recommendation of the President is essential for consideration of these Bills by either House and unless such recommendation is received, neither House can pass the Bill.
- In other words, the recommendation of the President is not required at the introduction stage but is required at the consideration stage.

## New model to predict ionospheric electron density

- Indian Institute of Geomagnetism (IIG), Navi Mumbai, an autonomous institute of the Department of Science & Technology, Govt. of India researchers have developed a global model to predict the ionospheric electron density with larger data coverage—a crucial need for communication and navigation on April 20, 2020.
- A new Artificial Neural Networks based global Ionospheric Model (ANNIM) have been developed using long-term ionospheric observations to predict the ionospheric electron density and the peak parameters.
- ANNs replicate the processes in the human brain (or biological neurons) to solve problems such as pattern recognition, classification etc. and very few attempts have been made to model the global ionosphere variability using ANNs.
- Tracking the variability of the lonosphere is important for communication and navigation. Scientists have tried to model the ionosphere using theoretical and empirical techniques.
- The Artificial Neural Networks (ANNs) are showing potential to handle more complex and non-linear problems.
- The researchers developed a neural network-based global ionospheric model by using an
  extensive database consisting of nearly two decades of global Digisonde, Global Navigation
  Satellite System (GNSS) radio occultation and topside sounders observations.
- These datasets were processed with various quality control measures to eliminate spurious data points (outliers) and prepared for the training.
- The model developed by IIG researchers may be utilized as a reference model in the ionospheric predictions and has potential applications in calculating the Global Navigation Satellite System (GNSS) positioning errors.

- The discovered super Li-rich giants which have Li quantity which is equal to or in some cases, more than 10 times the present value, A(Li) =3.2 dex (measured in logarithmic scale relative to hydrogen).
- Lithium (Li), is one of the three primordial elements, apart from Hydrogen and Helium (He), produced in the big bang nucleosynthesis (BBN) whose models predict primordial Li abundance (A(Li) ~2.7~dex).
- The team embarked on cracking this long-standing problem in stellar astrophysics.
- They showed for the first time that the Li enhancement in giants is associated only with central He-burning stars, which are also known as red clump giants.

- Technically called "convalescent-plasma therapy", the treatment aims at using the immune power gained by a recovered person to treat a sick person.
- Indian council for medical research (ICMR) the top authorising body in India has given approval to the SCTIMST for carrying out the novel treatment.

## **Convalescent-plasma therapy:**

- When a pathogen like novel coronavirus infects, our immune systems produce antibodies.
- Like the police dogs, the antibodies span out to identify and mark the invading virus.
- White blood cells attach the identified intruders, and the body gets rid of the infection.
- The therapy, like blood transfusion, harvests the antibody from a recovered patient and ingest into a sick person.
- Helped by the antibody, the immune system mounts robust combat on the virus.

#### Antibodies:

- Antibodies are one of the front-line immune response to an infection by a microbe. They are
  a particular type of proteins secreted by immune cells called B lymphocytes when they
  encounter an invader, such as a novel coronavirus.
- The immune system designs antibodies that are highly specific to each invading pathogen. A particular antibody and its partner virus are made for each other.

## **Treatment procedure:**

- Blood is drawn from a person who has recovered from COVID-19 sickness.
- The serum is separated and screened for virus-neutralizing antibodies.
- Convalescent serum, that is the blood serum obtained from one who has recovered from an
  infectious disease and especially rich in antibodies for that pathogen, is then administered to
  a COVID-19 patient.
- The sick acquires passive immunisation.
- Potential donor would be examined before the blood serum is extracted and given to a sick person.
- First, the swab test must be negative and the potential donor has to be declared as cured.
- Then the recovered person has to wait for two weeks.
- Or else the potential donor should be asymptomatic for at least 28 days.
- Either of the two is mandatory.
- Initially the treatment will be tried in a small number of patients. At present it is permitted as an experimental therapy for restricted use for severely affected patients only.

#### How is it different from vaccination?

- This therapy is akin to passive immunization.
- When a vaccine is administrated, the immune system produces the antibodies.
- Thus, in a later date, when the vaccinated person is infected by that pathogen, the immune system releases the antibodies and neutralise the infection.
- Vaccination provides lifelong immunity.
- In the case of passive antibody therapy, the effect lasts only up to the time the antibodies injected remain the bloodstream.
- The protection given is temporary.
- The mother transfers antibodies through breast milk to an infant before the child could build her own immunity.

## **History:**

- Way back in 1890, Emil von Behring, a German physiologist, discovered that the serum obtained from a rabbit infected with diphtheria was effective in preventing the diphtheria infection. Behring was awarded the first-ever Nobel prize for medicine in 1901.
- Antibodies were not known at that time. Convalescent serum therapy was less effective and had substantial side effects.
- It took many years before the antibody fraction could be separated. Still, the unintended antibodies and impurities caused side effects. How long the antibodies will remain in the recipient?:
- After the antibody serum is given, it will stay on the recipient for at least three to four days

## Challenges:

This therapy is not simple to harness, primarily due to the difficulty of obtaining significant
amounts of plasma from survivors. In diseases like COVID-19, where most of the victims are
aged, suffering from other medical conditions such as hypertension, diabetes, and so on,
not all recovered patients can volunteer to donate blood.

## **Cytokine storm:**

- A cytokine storm is an overproduction of immune cells and their activating compounds (cytokines), which, in a flu infection, is often associated with a surge of activated immune cells into the lungs.
- The resulting lung inflammation and fluid buildup can lead to respiratory distress and can be contaminated by a secondary bacterial pneumonia — often enhancing the mortality in patients.
- Cytokine storms are associated with a wide variety of infectious and noninfectious diseases.
- The term was popularized largely in the context of avian H5N1 influenza virus infection, bringing the term into popular media.

## Role of cytokines in the immune system:

- Cytokines are signalling proteins that are released by cells at local high concentrations a
  cytokine storm or CSS is characterised by the overproduction of immune cells and the
  cytokines themselves because of a dysregulation in the process.
- A severe immune reaction, leading to the secretion of too many cytokines in the bloodstream, can be harmful since an excess of immune cells can attack healthy tissue as well.

- Some of them are new to humans, and hence we do not have immunity against them and some are re-emergence of old diseases.
- Studies indicate that the frequency of these outbreaks has increased significantly in the last 20 years.
- We have had three pandemics since 2000 Severe Acute Respiratory Syndrome (SARS) in 2003, H1N1 (Swine flu) in 2009 and now Covid-19.

### Disease and there host:

- SARS and Covid-19 spread from civet cats/ pangolin and bats in China and swine flu from an intensive pig farm in Mexico.
- In between, we have had regional outbreaks of bird flu from poultry,
- The Middle East respiratory syndrome (MERS) from camels,
- Ebola from monkeys and pigs,
- Rift Valley fever from livestock,
- · West Nile fever from birds,
- Zika from monkey and
- Nipah from bats.

#### Cause:

- The root cause of all the above diseases can be broadly put under three baskets:
- 1. Environmental destruction-
- Due to deforestation and habitat loss, wild animals and humans are now nearby, leading to the spillover of animal diseases into humans. e.g. Ebola, West Nile virus, Nipah and Zika.
- 2. Cultural practices-
- The practice of eating exotic wildlife, sometimes raw, is spreading novel pathogens to humans.
- Both SARS and Covid-19 have origin in the wildlife markets in China.
- But the practice of eating wild animals is not restricted to China; it exists in one form or another across the world.
- 3. Intensive animal farms-
- The industrial farming of animals, by keeping animals very close to each other and pumping them with growth promoters like antibiotics, is another cause. e.g.Bird flu and swine flu.

- The mission is believed to help protect future astronauts from Solar Storms while going to the Moon or Mars.

- Together, these will observe radio images of low- frequency emission from solar activity and create 3D maps to locate the origin place of a solar particle storm on the sun.
- The mission has come true because of the success of DARPA high frequency research and Mars cube one (MARCO).
- The mission is to study sun's spectrum. This is important as sun's spectrum cannot be studied from the earth due to the ionosphere.

## Schedule H1 Drug:

- The Drugs and Cosmetics Rules, 1945, are the set of rules under The Drugs and Cosmetics Act, 1940, which has provisions for classification of drugs into different schedules and also guidelines for storage, sale, display.
- Schedule H1 has been introduced through Gazette notification GSR 588 (E) dated 30-08-2013 to check the indiscriminate use of antibiotics, anti-TB and some other drugs in the country.
- The schedule contains certain 3rd and 4th generation antibiotics, certain habit forming drugs and anti-TB drugs.
- As per government notification, these drugs are required to be sold in the country with the following conditions:
- The supply of a drug specified in Schedule H1 shall be recorded in a separate register at the time of the supply giving the name and address of the prescriber, the name of the patient, the name of the drug and the quantity supplied and such records shall be maintained for three years and be open for inspection.
- The drug specified in Schedule H1 shall be labelled with the symbol Rx which shall be in red and conspicuously displayed on the left top corner of the label.

- It will also be a bitter blow to sponsors and major broadcasters who rely on this four-yearly event for critical advertising revenue.

## **History:**

- Olympic Games originated in ancient Greece and were an intrinsic part of a religious festival. They were held in honour of Zeus (the greek god of the sky) at Olympia in Greece.
- The first modern Olympic Games were held in 1896 at Athens (Greece).
- The architect of the modern Olympics Games was Pierre, baron de Coubertin.
- International Olympic Committee (IOC) was created on 23 June 1894 and is the supreme authority of the Olympic Movement.
- It is a not-for-profit independent international organization.
- The Olympics have been held every four years since 1948.
- The Olympics have never before been delayed, though they were cancelled altogether in 1916, 1940 and 1944 during the two world wars, and major Cold War boycotts disrupted the Moscow and Los Angeles Games in 1980 and 1984 respectively.
- It is also considered as the first postponement of an Olympics in peacetime.
- In 1940, Japan was to be the first Asian country to host the Olympics.
